





Annandale Area/Look for walleyes in 10 to 14 feet using large leeches and night crawlers. Clearwater will be very good along with Cedar and Sylvia. Crappie action is Clearwater, Sugar, Sylvia and Pleasant on crappie minnows and flu flus, mini jigs and cubby jigs in the shallows.

#### HOW'RE THEY BITING?

#### (Excerpts from the Minnesota Conservation Volunteer)

All anglers have their favorite fishing holes. But few anglers can keep their favorites to themselves anymore. Record numbers of anglers have changed fishing on Minnesota lakes.

Fishing license sales tell the story of more anglers on the water. In 1911 Minnesota began to sell fishing licenses to non-residents for \$1. Resident fishing licenses first went on sale in 1927 and cost 50 cents each. The number of licenses sold each year has been on an upward trend ever since major world events such as the Great Depression and World War II caused dips in license sales. After the war, more cars and better roads gave anglers access to more lakes, and fishing license sales boomed.

Since the 1970s almost the entire increase in saleshas been due to resident fishing license sales. Today Minnesota has about 3.5 anglers fishing its waters for every one angler in the 1920s. More than 2.3 million people (licensed anglers and children who are not required to buy licenses) fish in Minnesota each year.

How much room does that leave each angler to fish? Dividing Minnesota's 3.8 million acres of fishable waters by 2.3 million anglers leaves 1.7 acres per angler. If an angler were to cast 51 yards in every direction from a boat without moving it, that angler would fish 1.7 acres.





#### REMINDER:

Please keep grass clippings from the lake! Leaves and grass are one of the biggest enemies of the lake. This makes phosphorus, which fertilizes algae.

If you must fertilize your lawn, PLEASE USE PHOSPHATE FREE PRODUCTS!





#### PERSONAL WATERCRAFT (Jet Skis)

What is personal watercraft? Sometimes known as Jet ski, Wet Jets, Wave Runners, Sea Doos, water scooters etc., a personal watercraft is defined by law as a motorboat that is: 1) powered by an inboard motor powering a water jet pump or by an outboard motor powering a water jet pump or by an outboard or propeller-driven motor; and 2) designed to be operated by a person or persons sitting, standing, or kneeling on the craft, rather than in the conventional manner of sitting or standing inside a motorboat.

All personal watercraft are considered motorboats and therefore, any regulations, that govern other motorboats (such as fishing boats, cabin cruisers, etc.), also govern personal watercraft.

Anyone operating or riding on a personal watercraft must wear a U.S. Coast Guard approved Type 1, 11, 111 or V personal flotation device (PFD or life jacket).

Personal watercraft must travel at slow - no wake speed (5 mph or less) within 150 feet of non-motorized boats, shore (unless launching or landing skiers directly to or from open water), docks, swim rafts, swimmers, or any moored or anchoret boat.

OPERATION of personal watercraft is allowed only from 9:30 a.m. to 1 hour before sunset.



All watercraft, regardless of lenth, will need to carry and have readily accessible, one life preserver (PFD) for each person on board. Also, you should have a Type IV throwable devise (boat cushion or ring buoy) for the boat. Due to a change in the federal requirements, boat cushions are no longer acceptable as primary lifesaving devices.

USCG approved fire extinguishers are required on boats with enclosed fuel or engine compartments.

Persons 12-17 years of age are required to have a watercraft operator's permit to operate a boat of more than 25 horsepower, unless someone at least 21 is on board in reach of the controls.

This information was taken from the 1999 Minnesota Fishing Regulations.
