



Memories from the West Side of Cedar Lake By Diane Salls

Bruce and Ella Gordon owned the farm from 76th street, north to the dam and from County Rd 6, East to Cedar lake. Ella and my grandmother, Emma Dierke were sisters. In the early 30's, when money was scarce, Bruce asked my father, Harold Dierke, to survey part of the lakeshore to sell for cabin lots, and in return he received our lot as payment. Dad went beyond that and arranged to sell several lots to family and friends. He didn't want disagreements to come between his friends so he sold them non-adjoining lots. Lawrence and Angie Tysk (childhood friends of Dad and co-workers of my mom, Florence Dierke) bought 2 lots at 8054 Irvine. Their lot was full of daisies which they didn't mow until after the daisies died in the summer.

Grandma and Grandpa Dierke bought 2 lots at 8024 Irvine. The main part of their cabin was an old chicken house brought down from the farm. In their basement they had a large barrel of kerosene where we filled our lamps and kerosene stove.

Uncle Charlie and Aunt Cora (Mom's

sister) bought a lot at 8010 Irvine. They had a large wrap around porch which had 6 double beds. Later their cabin was moved to the Cedar Acres Landing where it was used as a picnic pavilion.

Our cabin is at 7992 Irvine. Dad built it from power poles he bought from the Northern States Power Co., where he worked. The stones for the spit rock fire place came from the corn field across the road. Dad was rather short and the logs were moved by hand, so the walls are

short and some of the cross beams have only a 6ft. clearance. Dad kept changing and adding onto the cabin and it was still unfinished when he died in 1982.

Emil (he worked with Dad) and Ruth LaSere bought the lot at 7966 Irvine. I spent many hours there playing cardboard records on their wind up phonograph. Their older daughter Cathy first went swimming in the Lake when she was 3 weeks old.

All the lots were eventually sold and the families there became our friends. Dad took on the responsibility of collecting money and having the road plowed every year.

These lots may seem small by today's standards but were plenty big when mowing with the old push mower. My brother Jim and I were thrilled when Dad put a washing machine motor on the old mower for our first power mower.

Other modernizations were; electricity in 1946, and the hand pump in the kitchen was replaced with running water; indoor plumbing in 1953 with a real bathroom. (But we missed stargazing while waiting our turn to use the outhouse.)

We "Westside Kids" spent many hours swimming and fishing, of course, but we also sewed doll clothes, put on musical shows for our parents, built forts out of sumac trees, and visited the farm animals. When a little older, we took a boat across the lake to the resort to buy milk and bread and to play their pinball machine. Sometimes, we walked into Annandale to see a movie or to get ice cream at the wonderful Candy Castle ice cream parlor. Jim shot at targets when the farm field became a gravel pit. Many of the other kids became very good water skiers, but Jim and I were "stuck" with a small fishing boat and a canoe.

Dad loved to entertain, and would have 50 to 75 coworkers and friends to our cabin for Fourth of July picnics, Brown's ice cream cones and fireworks. The neighbors joined us as we sat on blankets (trying to avoid mosquitoes) and applauded the amazing explosions of lights. There were always fireworks leftover which we used for the rest of the summer. Dad also entertained members of his square dance club who danced on the lawn. (They were then called Grasshoppers.) These were the Good Old Days of my childhood but many children and grandchildren of those first cabin owners are still making their Good Old Days every day they spend at Cedar Lake.

Membership Committee Update

The Membership Committee encourages membership and member involvement by focusing on several activities, including member satisfaction, the newsletter, the member directory, and the website. Mike Hankee is the 2010-2011 chair of the membership committee.

The CLCC membership is strong, with 171 (65%) duespaying members out of 265 property owners. This is approaching our record of 184 members that was set last year, and is well above the 50% average that "good" lake associations maintain.

Water Quality Committee

Greetings to my fellow CLCC members! I am pleased to introduce myself as the newly appointed Chairperson of the Water Quality Committee. For those of you who don't know me, I have had the privilege of enjoying summers on Cedar Lake for all 52 of years of my life, and previously served two terms on the CLCC Board back in the late 1990's/early 2000's. During my time on the Board, I was heavily involved in the water quality initiative that resulted in the project at the south end of our lake, often referred to as P-06. I am honored that the Board would ask me to take over this verv important position, and have big shoes to fill in succeeding Kevin Kolstad, who devoted a huge amount of time to this position over the past several years. A big thanks to Kevin for all the time and effort he put in on behalf of all CLCC members to ensure that Cedar Lake will remain the precious natural resource that we all know and love.

Good news and bad news to report. The bad news is that Eurasian Milfoil has been discovered in Cedar Lake, a discovery that the DNR confirmed this fall. The good news is that, based on a search that was conducted in late September, it appears that the location of the plants is confined to the north end of the lake, between the public access on County Road 6 and Schroeder Park.

On September 11, over 60 CLCC members attended a special meeting hosted by CLCC to discuss the discovery of Eurasian Milfoil in our lake. During this meeting, Kevin Kolstad presented samples of both Northern Milfoil (native to Minnesota lakes) and Eurasian Milfoil, and discussed how to distinguish between the two, something that is not all that easy. (Please see the In addition, we had pictures). guest speakers from Clearwater. Sugar, and Maple Lakes who discussed, in great detail, the action

plans they had in place with respect to controlling the Eurasian Milfoil in their lakes. They shared their wisdom about application methods and the costs associated with these plans. Finally, we asked for volunteers to sign up to become "Milfoil Warriors" to assist the members of the Water Quality Committee in developing and implementing an action plan to control the Eurasian Milfoil. If you did sign up and I have not yet contacted you, I will be doing so shortly to discuss your involvement. If you were unable to attend the meeting, but wish to become a Milfoil Warrior, please contact me at 612/303-4504.

What we have learned so far with respect to an action plan is that fall treatment of the plant is ineffectual, and the optimal time of the year for treatment is early spring, shortly after the ice goes out. As a result, my goal is to have a meeting of the Water Quality Committee members, including the Milfoil Warriors, in early December to start putting together an action plan – timing is critical given the fact that we will have to apply for a permit through the DNR. I intend to invite our friends from Clearwater. Sugar and Maple Lake to attend this meeting, as their experiences will be invaluable with respect to putting

together an action plan. In addition to assistance from these friends, the CLCC is now a member of Minnesota Waters, an organization that is designed to assist its members in matters such as battling Eurasian Milfoil. Several CLCC members plan to attend a three day seminar on invasive plant species that is being conducted by Minnesota Waters in November. I anticipate that what is learned at this seminar will be instrumental in developing our action plan.

Nominating Committee




By getting involved, I've learned so much about our lake and community, I can't even begin to tell you. More importantly, I've made lasting friendships by being a board member.

Before moving on to a couple of other topics, I do want to touch on the issue of financial resources required to fight the Eurasian Milfoil. At the current time, we have approximately \$35,000 in our invasive species control fund. Based on some of the numbers mentioned at the September 11 meeting by the Clearwater, Sugar and Maple Lake representatives, it appears that the balance in our fund could be depleted rather quickly, and that the annual donations to the fund from a portion of our membership dues will not be able keep pace with the annual expenses. As a result, an important part of the action plan we will be developing will include looking at the financial resources required to implement the action plan, and how to generate these resources. While we will certainly look at funding available through various grant and government programs (something that our membership in the Minnesota Waters organization will assist us in doing), I think that we all need to come to the realization that a significant portion of the funding will have to come from the CLCC members and other Cedar Lake property owners. Please be assured that the discovery of Eurasian Milfoil will not divert the attention of the Water Quality Committee away from the other invasive specie we are attempting to control, Curley Leaf Pondweed. The program that was put in place several years ago will continue in full force and effect.

Finally, with respect to Cedar Lake water quality monitoring, for the past six years we have participated in the Lake Monitoring Program, which is locally run by the Wright County Soil and Water Conservation District – this program assists groups, like the CLCC, that are active in lake stewardship. At the present time over 900 lakes, statewide, participate in this program. When an association such as the CLCC joins this program, volunteers (a big thanks to Carter Diers for leading the charge on this) from the association are trained to collect water samples and Secchi Disk readings (water clarity). The water samples are then forwarded to a lab for phosphorous and chlorophyll analysis. The results of the sample analysis and readings are then posted on line for viewing an assessment. The web site is: http://www.rmbel.info/Reports/ ReportsQuery.aspx (Search on Cedar Lake, Wright County, Lake # 860227) All the numbers and scientific data we are accu-

mulating on our lake may lead us to think that water quality is as cut and dried as a number. The more we learn about phosphorus levels and Secchi depth (water clarity) the more we respect the complexity of the lake and the interplay of temperature, rainfall, and best management practices. The impact of the P06 project will take a decade or more (not just a few years) to fully realize. I think we can all agree that the summer of 2010 was a particularly wonderful year of water quality and clarity on Cedar Lake and a positive sign of our individual and collective efforts to be stewards of the lake.

Go Native Start Planning Now

By Cheryl Wold Finally have all the garden and lawn work done for the season? When most of the trees and shrubs have lost their leaves, the green leaves of the buckthorn plants certainly stand out. Take note of where they are and in the spring, after the ground has thawed, remove the roots and all with the Weed Wrench available on loan from the CLCC. The CLCC Spring Newsletter will have more information on buckthorn and the Weed Wrench Program.

The winter season is a great time to plan future yard and shoreline projects. You might want to consider incorporating some native shrubs, grasses and wildflowers into your landscape. Native plants require very little maintenance once established, and are vitally important to preserving and sustaining nature's diversity – birds, bees, butterflies and more. The leaf-eating insects which feed on native plants are a major source of food for birds and other wildlife. Native shoreline vegetation helps stabilize the bank and filters out pollutants and runoff that degrades water quality.

Fish and Wildlife Conservation

Walleye Stocking

On Saturday October 16, 2010 the Fish and Wildlife Committee completed its first ever stocking of walleye fingerlings in Cedar Lake. After two years of raffles at our Spring Fling and Annual Fall Dinner, and with some generous donations, we were able to generate \$2,065!! With these monies we were able to purchase over 1900 fingerlings that were between four and eight inches in length, weighing 125lbs. A permit was obtained from the DNR and the walleye fingerlings were purchased from West Central Bait and Fisheries in New London MN. Rav Howard was gracious enough to offer his pickup truck for the transportation of the fingerlings to the Lake. We were then greeted at the release site (the public access on CR6) by some members of the CLCC Board and friends. Everyone was excited, and so were the fish, that guickly took off, looking for security in native vegetation after their release. You can watch a short clip of the release at .:

The DNR stocks Cedar Lake with walleye fingerlings every other year. Last fall the DNR stocked 10,685 fingerlings weighing 322lbs. We will continue to work closely with the DNR, so we can continue to improve our fisheries here on Cedar Lake.

Carp

It's great to hear reports that lakeshore owners are seeing fewer carp this year. It appears that our carp barriers are working. There was also a large winter kill of carp in Swartout Lake last winter. With fewer carp stirring up our lake bottom and with the Segner Pond in place, we are making progress in our water quality.

Waterfowl Migration

Cedar Lake can be a great place to observe waterfowl migrating in the fall. It is one of the last lakes in the area to freeze over, so this provides late season viewing of various species of waterfowl. Last fall, just before Thanksgiving, flock after flock of Tundra Swans decided to rest on Cedar Lake for a few hours before continuing their migration. Normally they stop on the Mississippi River in Southeastern MN, but for some reason they decided to use Cedar Lake for a short resting place. What a site it was!!

Two adult loons in Minnesota are equipped with satellite transmitters and geolocators in an effort to study the movements and foraging patterns of fish-eating birds while they migrate through the Great Lakes. Some Minnesota loons winter off the Atlantic coast from North Carolina southward to Florida, but more winter along the Gulf coast from Alabama and the Florida panhandle southward along the western coast of Florida to the Florida Keys. At this point, we don't know the extent of the threat or what percentage of our loon population could be lost to the oil spill. Unfortunately, there is no strategy that will prevent the loons from migrating or from choosing another wintering area. Their migratory routes are "hard-wired in their genes" and most will be heading for the Gulf.

Cedar Lake Conservation Club Applies for Star Lake Designation

Minnesota's State Legislature formally established a Star Lakes and Rivers program in 2008 (Minnesota Statutes 2008 103B.701). This legislation also creates a Star Lake Board charged with promoting the program, developing more specific and detailed procedures and criteria for applicants, formally designating Star Lakes and Star Rivers, and implementing and overseeing ongoing program operations.

The Star Lake Board was established to encourage and reward citizen-based lake and river associations that actively participate in protecting and enhancing surface waters of Minnesota. The enabling legislation reflects a belief that broad citizen participation provides a very cost effective means of protecting our water resources. The Star Lakes initiative is designed to foster broader citizen participation through financial incentives. educational efforts, and public-private partnerships.

The Star Lake legislation also provides lake and/or river associations with general eligibility requirements and procedures for applying for Star Lake or Star River status. To attain a Star Lake or Star River designation, a lake or river association must, at a minimum: develop a lake or river management plan according to specified guidelines; maintain a membership or participation of at least 50 percent of private shore land owners; participate in a water quality monitoring program meeting Minnesota Pollution Control Agency standards; and meet at least annually to review the management plan and to monitor progress. CLCC exceeds these criteria!

During Spring Finals, she and her friends would come out to my cabin to study - quiet, no distractions, etc. Because the water would be turned off. they would flush the toilet with buckets of water from the lake and make Hobo Packets on the grill - no dirty dishes. Hobo Packets

1 Lb. hamburger with onions. Form into patties and arrange on individual pieces of heavy duty foil. Add baby carrots, potatoes sliced like french fries, salt and pepper. Seal the packets and arrange them around the edges of a hot grill. Grill them for 45 min. to 1 hour. Study one hour - inside or out - depending on the weather. Then enjoy dinner using plastic utensils and throw away the "dishes"! These also work well baking them in the oven.

The Star Lake Board will review applications. Lake and/or river associations that have attained the Star designation are eligible to apply for special project grants that will be disbursed through a competitive process.

We submitted our application on October 15th. Those involved with the application process feel we have an excellent chance of being recognized as a Star Lake and we hope it will lead to some funding help for our work.

Having a Lake Management Plan is a key part of obtaining the recognition. Cedar Lake has an extensive plan that can be found on our website,

www.cedarlakecc.org. For those not familiar with our LMP, it contains information on just about anything you would like to know about our lake and the activities to support our lake. Take a look!
