Greetings,

While you turn your thoughts to the upcoming Holiday Season, please take a few minutes to read this edition of the CLCC Newsletter. As you know, much has happened this past year.

In September, after months of research, education, and discussions, the Clearwater River Watershed District (CRWD) passed an amended P06 Swartout and Cedar Water Quality Improvement Project. Hats off to everyone who participated. New offerings by the Club this year were the Native Rain Garden and Shoreline Restoration Class in April and the Native Plant Sale and shore land tours in June. They were very successful and as a result, the Wildlife Committee has recommended we do another native plant sale and tour of lakeshore restoration projects again next year. Our third annual Summer Picnic was another big hit with over 270 people attending. Members donated over \$480 to the Walleve Fund which will be used next fall when CLCC stocks Cedar Lake.

My last highlight is to thank the 45 visionaries who donated over \$7,100 to the various CLCC Visionary Funds. Your donations truly make a difference.

The CLCC Annual Meeting was held on September 21st at the Corinna Township Hall. The CLCC membership elected three new Board of Directors: Bill Arendt, Glenn Baird and Orv Jonsrud. We also said thank you to three outgoing members: Leslie Kreutter, Kathy Jonsrud, and Chervl Wold. Leslie Kreutter was the Merchandise Chair and also a past president. Kathy Jonsrud was vice president for one year and president for two years and just finished her last year. Kathy is staying on as the Water Quality Committee Chair. Cheryl Wold worked on the

Fish and Wildlife Committee and was responsible for setting up training for our native shore land restoration projects and plant sales. A huge thank you to these three outgoing board members for their great service and contributions to the CLCC.





CLCC FISH AND WILDLIFE COMMITTEE

The Cedar Lake Conservation Club has worked very hard to keep our lake one of the finest in the area, not only for quality fishing, but as the host to many species of birds, animals, reptiles, insects and native plants. We will continue to work closely with the DNR and other agencies to help make good management decisions for our lake. With everyone practicing good lake stewardship and working hard to protect our water quality, the lake and its wildlife will be here for us to enjoy in the future.

New Area Fisheries Supervisor: Joe

Stewig is the New Area Fisheries Supervisor. He has replaced Paul Diedrich who retired after many years of serving our area. We welcome Joe to his new position and look forward to working with him and his staff.

Cedar Lake Survey: DNR Fisheries will be completing a lake survey in Cedar Lake next year, 2014. The last survey, completed in 2006, can be found at: www.dnr.state.mn.us/lakefind/ showreport.html?downum=Joe stated

Tullibee and Lake Health: Tullibee are also known as Cisco or Lake Herring. They are silvery-sided, iridescent fish of the open water beyond the shore with dainty mouths that feed on small crustaceans and aquatic insect larvae. Tullibee don't often end up on the end of anglers hooks because they don't typically eat bait-sized prey. These members of the salmon family can weigh up to several pounds in inland lakes. Rare 5 pounders have been caught, but typically they weigh less than a pound. One thing we do know that if you have tullibee in a lake, things are usually pretty good with the lake. Tullibee are typically restricted to the northern half of Minnesota. They must have cold, oxygen-rich water to thrive. Even slight changes in temperature and available oxygen can squeeze these sensitive fish out of their comfort zone, particularly in central Minnesota which is at the southern extent of their range. The Tullibee are not the only living things affected by change in oxygen and temperature, two major drivers of the lake ecosystem dynamics. Low oxygen concentrations in the deeper water is one factor resulting in a severe deterioration of living



conditions for most fresh water organisms. Because tullibee are more sensitive to these changes than most other species, their state of well-being can signal the well-being of our lake as well as the northern pike and walleye that feed on tullibee. In 1996 Tullibee were found in the DNR's net surveys but in 2006 none shown up in their nets. Was that a sign of degrading water quality back then? In February 2011, while fishing for crappies on the north side of the lake a Tullibee was caught in our fish house. Surprised? Yes we were. Was that a sign of Cedar improving in water quality? Maybe.... Or was it just one of few remaining in the lake?

We must continue to protect our lake from excess nutrients such as phosphorus to maintain sufficient oxygen levels in Cedar Lake. Protecting our lake from nutrient enrichment starts at the shore and ends at the farthest edge of the lake's watershed. Here are some things you can do:

- Leave shoreline and aquatic plants in place to prevent shore erosion;
- ◊ Leave lakeshore wetlands intact to filter pollutants;
- ◊ Properly maintain septic systems; and
- Fertilize lawns WITHOUT phosphorus to help reduce oxygen loss in the lakes hypolimnions.

With the Clearwater River Watershed District's revised PO6 project about to begin, and with Segner Pond in place, we have been moving in the right direction to get the water filtered before it gets into Cedar Lake. We just may see the return of the Tullibee to Cedar Lake in numbers.

And, if you happen to catch a Tullibee this winter, please send me a photo, location, date and time of catch. It just might just be a good sign of things to come.


CLCC board meetings are open to members and include an open forum for new business. The board welcomes and encourages member attendance and participation.

2014 CLCC Walleye Stocking Fund Campaign - \$5,000 Goal

Do you believe this walleye that Jerry O'Keefe is proudly showing off? He caught it "somewhere on Cedar Lake" and he recognizes the stocking efforts that made this possible. Jerry states, "I have been fishing on Cedar for over 20 years, and this is one of my greatest catches." After measuring it (30 inches) Jerry threw it back to be caught again and bring someone else a boatload of fun.

How was this possible? CLCC has a cooperative arrangement with the DNR to stock Cedar Lake with walleye every year. The DNR pays one year and CLCC pays the next. Last year, CLCC raised \$5,000 and purchased about 5,000 fingerlings. This year is the DNR's turn.

CLCC is up again for 2014, so we want to *beat* what we did in 2012. The CLCC Walleye Stocking Fund is currently at about \$500. We need your help to reach our October 2014 goal of \$5,000 or approximately 140 lbs. which is just over 5,000 fingerlings. Our supplier estimates there are approximately 36 fingerlings to a pound. We go for larger fingerlings since their chances of survival are higher. The Fish and Wildlife Committee is challenging you to participate in this fundraiser. Your help is greatly needed and appreciated.



Recognition of Water Quality Committee Members

2013 Vegetation Mapping

Every three years, the CLCC conducts a total vegetation mapping of the lake. This is not only a required activity by the DNR, but an important tool to understand the impact and effectiveness of the AIS treatment. The vegetation mapping is extensive and precise, using GPS technology which is shared with the DNR and the AIS treatment vendor (PLM). Three bids were submitted for the project which was awarded to Wenck and Associates at a bid of \$4,000. The project came in about 10% under budget for a final price of \$3,623.

There were two steps to the project: the first mapping was in late May and the second mapping was in August. We have received the preliminary report, which indicates

that there will be more curly leaf pond weed to treat in 2014. There are new areas in the southeast and west. Additionally, there is a patch of Eurasian Water Milfoil (EWM) of approximately 20 acres in the north east side. The Committee will be working to better understand all the data, but initial observations are that we have a very nice mix of emergent and submerged native vegetation. For example, the area on the north side where we treated the EWM in 2012 appears to be filling in with native vegetation.

This vegetation mapping is extremely valuable to help with future approaches to controlling aquatic invasive species. As a value add, PLM conducted a EWM inspection in late October, so there is a great deal of timely data. The Water Quality Committee will continue to evaluate the results and collaborate with all the stakeholders involved as we plan for the 2014 treatment.


DNR Grants Approved

As mentioned in the July newsletter, CLCC received a DNR grant of \$1500 to help treat the lake's Aquatic Invasive Species, which was enough to cover the 2013 Eurasian Water Milfoil treatment costs. We hope the grant program continues and are watching for the 2014 grant notice so we can apply to receive more funds.

The 2013 DNR permit was for 8 acres. The cost was \$4,476. Because of the treatment resistance over the past several years on the south side, we worked with our vendor and the DNR to use a newer chemical—Clearcast.

Unfortunately, the CLP treatment this year was not effective. Though this is disappointing, in the whole scheme of our long term strategy, this is a minor set-back. Our vendor stands behind our contract and will credit us for 100% of the 2013 CLP treatment costs.

Eurasian Water Milfoil (EWM)

We had limited EWM to treat this year. Our permit was for 1.5 acres and the treatment was done in late July. In 2012 we treated 22 acres.

DNR Inspections on Cedar

As serious lake people know, there is not a magic bullet to prevent aquatic invasive species from entering our lake. Education is the key! We had DNR staff provide inspections on CTY RD 6 on several days this summer. This is in addition to the new inspections at Schroder Park which were sponsored by CLCC and Schroeder Park.

PO6 Project Enhancements—Approved

On September 11th, 2013 the Clearwater River Watershed District (CRWD) Board of Managers held a public hearing regarding enhancements to its existing PO6 project. The initial 2006 project was intended to help reduce phosphorus and carp population in Cedar Lake (see <u>www.crwd.org</u> for more details about PO6). After the public hearing, the CRWD Board of Managers voted to approve the proposed enhancements.

The public hearing was well attended. The project engineer gave a presentation and answered questions for about an hour. It was mostly educational in nature and many from the lake community asked questions about the project's purpose, effectiveness, and ongoing maintenance requirements.


The finances were discussed. With an estimated total cost of \$554,000, the Legacy Fund grant that the CRWD received for \$277,900 helped make the project feasible. More public discussion was allowed and there was one letter read that strongly opposed the project. The rest of the comments were favorable.


The two projects will temporarily "slow down" a portion of the runoff during rain events and reduce the amount of phosphorus coming into Cedar. The projects are located just south of Cedar (near Hwy 55) and east of Swartout Lake. The details of the design of the project continue to evolve.

CRWD sent assessments to affected homeowners for the PO6 enhancements. The amount for a lake shore owner on Cedar is a one-time payment of \$500, or a four-year payment option can be selected. The maintenance costs for these projects are expected to be low and both projects are expected to have a long life. Construction may begin as early as this winter.

The addition of these two projects to PO6 represents over two years of CLCC work in collaboration with the CRWD. Countless meetings have been attended and many questions asked. We are indeed fortunate to be part of the Clearwater River Watershed District as they are recognized as a premier watershed and have received more grants than any other watershed in the state. Our hope is that the generations to come will look back and reflect that we were wise and proactive and did our very best to protect and preserve our beautiful lake.
