Any Cancellation 29 days prior to the event no refund will be given on the 50% deposit.

IF AN EVENT IS CANCELED WITHIN 7 DAYS OF THE EVENT 25% OF THE REMAINING BALANCE WILL BE RETURNED.

LESS THAN 48 HOURS NO MONIES WILL BE RETURNED.
