## President's Message

#### **GNJ Annual Conference 2022 Report**

On March 3, 2022, our organization launched a new brand, a new name and a new mission statement: "United Women in Faith seeks to connect and nurture women through Christian spiritual formation, leadership development, creative fellowship, and education so they can inspire, influence and impact local and global communities." This newly invigorated sisterhood continues to work to improve the lives of women, children and youth. We are enjoying the diversity and new opportunities to work together that redistricting has created in our United Women in Faith districts.

In the spirit of inclusiveness, our Greater New Jersey United Women in Faith has adopted a Welcome Statement that declares that "God's grace is extended to all God's children without exception." We continue our focus on climate justice and the criminalization of communities of color. These emphases may be seen in our spring and fall meeting topics, Mission u classes, and our Charter for Racial Justice<sub>1</sub> conversations. We held two leadership development events, one in January, entitled "Lead Like MLK," and "Recipes for Success" in June.

The spring meeting on April 9 was held virtually. After our opening worship and keynote speaker, we went into breakout rooms by district, a format that was successful the previous year. The theme was "With Hearts and Healing Let Us Sit Together," a panel with Shirley Hager, gkisedtanamoogk, and Shirley Bowen, based on the book, <u>The Gatherings: Reimagining Indigenous-Settler Relations</u> by Shirley Hager and the Mawopiyane. The offering was divided between the UWF Pledge to Mission and Wabanaki Public Health and Wellness.

Mission u in July was our first time as a hybrid event with live and virtual attendees. "Who Can We Be Together?," a study of Luke 13, was offered in both the 3-day (hybrid, 25 attendees) and 1-day (virtual, 34 attendees) schools. Thank you to our team of teachers: Don Kirschner, Wilhelmina Jackson, Jay Brown, Kathy Schulz, and Rev. Dr. Sueng Lin Baik, who led 84 people at the one-day Korean school.

The fall annual meeting on October 15 was entitled "Intersectionality: Where Love and Justice Meet." Our speaker, Dr. Mark Miller, addressed the "overlapping and interdependent systems of discrimination," called intersectionality. The offering was divided between The Trevor Project and the Peyton Heart Project, which also received the ingathering of yarn.

The Charter for Racial Justice series continued in the fall with three sessions. On September 30, Cynthia Mosley, Chair of GNJ's CoNAM and Ragghi Rain, Chair of Native American International Caucus, were speakers for "Justice for Indigenous Children." This coincided with the Week of Prayer and Action and the National Day of Remembrance for U.S. Indian Boarding Schools. In November, we had a panel of Rev. Junehee Yoon, Obed Perez & Rev. Jessica Campbell, followed two weeks later by Meg Isbitski, Diversity Specialist, Somerset Co Dept of Human Services. The sharing of their stories helped to "Know Your Neighbor in the LGBTQIA Community."

Our Spiritual Enrichment Advisor Barbara Miller led four virtual micro-retreats. There was guided meditation with coloring, yoga, and Taize, in a series of "Let's Play, Let's Pray, Let's Be Still." United Women in Faith is very intentional about offering these spiritual opportunities and accepted our conference proposal for a pilot program of the "Soul Care Retreat." A diverse "Design Team" from throughout the Conference is working together to ensure that this first NEJ Soul Care Retreat provides all who attend with an atmosphere of relaxation, rejuvenation and spiritual nourishment.

We are pleased to report that we met our Pledge to Mission, despite the pandemic, virtual meetings and redistricting. Please go to our <u>www.gnjumw.org</u> website for more information and events. ## Methane Pollution – Make an Impact



The Environmental Protection Agency (EPA) recently released an updated rule to cut methane, so called "natural" gas, and other harmful pollutants from new and existing oil and gas operations. Methane is a potent climate-warning gas as it's 80 times more detrimental than carbon dioxide to global warming and can also harm the health of our families and communities.

The EPA's new Methane rule requires extended monitoring, increases reporting and correction requirements, and calls for recovering and rerouting wasted methane into production lines reducing the need for flaring. Join us in supporting this measure for cleaner air by messaging EPA in support of this new rule!

For many years, United Women in Faith has been urging the EPA to strengthen the proposed rule to protect public health and the climate and use all of its authority under Clean Air Act §111(d) to cut methane pollution from oil and gas development by 65 percent by 2025.

We know that methane pollution increases the threat of climate change and negatively impacts air quality. Black, Indigenous, Latino, Asian, and low-wealth communities will be forced to deal with the worst impacts of both climate change and methane pollution. Thus, we must urge the EPA to act urgently to address this climate injustice to ensure that the health of God's creation and God's people is protected.

Please join United Women in Faith and the Breathe Again Collaborative calling for EPA to finalize this methane proposal—to strengthen its monitoring and other protections to help ensure everyone's right to clean air.

#### HUMAN TRAFFICKING AWARENESS

JANUARY IS HUMAN TRAFFICKING AWARENESS MONTH - COVENANT HOUSE. NJ Human trafficking affects people from all demographic, social and economic groups but homeless youth are particularly vulnerable. Covenant House of NJ reports that 9.2% of clients they screened (homeless youth ages 18 to 24) experienced human trafficking at some point in their lives. According to the University of Chicago Voices of Youth Count, a third of youth who are homeless had once been part of the foster care system and half of homeless youth had been in the juvenile justice system, in jail or in detention.

Not having a high school diploma or equivalency is the highest risk factor for youth homelessness. A caring supportive adult positively impacts the resiliency of children and youth coping with adverse childhood experiences (ACES).

Julia Einbond will become the new Executive Director for Covenant House in NJ effective July 1 2023. Covenant House NJ has become a national expert on human trafficking under her leadership as associate director of CHART, the Covenant House Action Research Team. Covenant House of New Jersey is one of CWU-NJ state projects in 2022-2023. The Office of the NJ Attorney General and the Division of Criminal Justice will hold their annual Human Trafficking Awareness program at the Trenton War Memorial on Thursday Jan 26th: The focus of the morning session is Sex Trafficking and Persons with Disabilities. The afternoon session includes screening of the documentary Sextortion: the Hidden Pandemic, followed by Q&A about on-line grooming and sextortion of young people.

#### EQUALITY OF RIGHTS

EDUCATION. EMPOWERMENT. EQUALITY. Sustained Advocacy - We Can Make a Difference. On January 11th we celebrate the life and vision of Alice Paul -Feminist, suffragist, political strategist. Alice Paul dedicated her life to the single cause of equality for women. Her vision was a world where men and women were equal partners in society: **Simple Equality**.

This year is the 75th anniversary of the Seneca Falls Convention where Alice announced the "Lucretia Mott amendment" to the US Constitution: "Men and women shall have equal rights throughout the United States and everywhere under its jurisdiction." In 1943, the amendment was re-written as the "Alice Paul amendment": "Equality of rights shall not be denied or abridged by the United States or by any state on account of sex". The Equal Rights Amendment (ERA) as passed by a Joint Resolution of Congress on March 22 1972 reads (in part) the following article is proposed as an amendment to the Constitution of the United State which shall be valid for all intents and purposes a part of the Constitution when ratified by the (continued on page 12)





# **Social Justice - Taking Action**

Social action is defined as the best way to inspire change by confronting decision makers in a concerted action. It can range from organizing a letter-writing campaign to assembling tens of thousands of people in the state or national capital to promote or protest government actions. Social justice is a fair and equitable division of resources, opportunities, and privileges in society to empower our communities and act in the best interests of all people through social advocacy and justice.

This year, GNJUWF will schedule brainstorming sessions to add to our efforts of social justice through education and training. We are pursuing plans to contact our legislators, in writing and in person, and encourage their review and action on current legislative bills for societal improvements that mirror our efforts – Congressional Outreach.

Some of the focus areas other organizations have embraced are:

- Voter Education, Registration, and Mobilization to empower communities to utilize their most powerful tools of community change and advocacy during local, state, and national elections;
- Public Policy Forums that create convenings of non-partisan open dialogue on policy challenges and the direction of our country.
- Candidate Forums, non-partisan public events featuring candidates running for office who wish to express their positions on issues; and
- Public Servant's Guides developed to highlight women currently serving in political leadership positions along with information on how to create a pathway for women in politics.

# **Gun Control Bill Passed**

In June 2022, the U.S. Congress passed and President Biden signed the Bipartisan Safer Communities Act (S.2938) – the most significant firearms legislation in about 30 years. It imposes tougher checks on young buyers and encourages states to **remove guns from people considered a threat**. It is the first time in decades that proposed reforms have received this level of support from both Democrats and Republicans. The bill came after mass shootings last month at a supermarket in Buffalo, New York, and a primary school in Uvalde, Texas that left 31 people dead. The reforms include tougher background checks for buyers younger than 21, \$15 billion in federal funding for mental health programs and school security upgrades, funding to encourage states to implement "red flag" laws to remove firearms from people considered a threat, and closing the so-called "boyfriend loophole" by blocking gun sales to those convicted of abusing unmarried intimate partners.

On July 29, 2022, the U.S. House of Representatives passed the **Assault Weapons Ban of 2022** (H.R. 1808) and was received by the Senate on August 1, 2022, read twice and referred to the Committee on the Judiciary. The bill makes it a crime to knowingly import, sell, manufacture, transfer, or possess a semiautomatic assault weapon (SAW) or large capacity ammunition feeding devise (LCAFD).

legislatures of three fourths of the several states within seven years from its submission by the Congress.

ARTICLE— <u>Section 1</u>: Equality of rights shall not be denied or abridged by the United States or by any state on account of sex. <u>Section 2</u>: Congress shall have the power to enforce, by appropriate legislation, the provisions of this article; <u>Section 3</u>: This amendment shall take effect two years after ratification.

2023 is the 100th anniversary of continued efforts to add the ERA to the US Constitution. The required 38 states have now ratified the ERA, the final state required for ratification was Virginia which voted YES on Jan 16 2020. The House of Representatives passed legislation removing the deadline for ERA ratification. Senate Majority Leader Chuck Schumer has committed to hold a Senate vote to remove the deadline for ratification by the end of March 2023. **LET'S GET IT DONE in 2023!**

## The Secret Power of the 8-minute Phone Call



<u>A study</u> of 240 adults in 2021 found that when participants received brief phone calls a few times a week, their levels of depression, loneliness and anxiety were "rapidly reduced" compared with people who didn't receive a call. As Dr. Waldinger writes in his book, "a few adjustments to our most treasured relationships can have real effects on how we feel, and on how we feel about our lives — a gold mine of vitality that we are not paying attention to."

Today your goal is to think of a person you love, someone you miss, someone you wish you connected with more often.

Send that person a quick text asking if they can chat on the phone for eight minutes — ideally today, but if not, schedule it for some time this week. You can even copy and paste the following:

Hi! I read <u>this</u> in The New York Times and it made me think of you. Want to schedule an eight-minute phone call this week?

After the eight minutes are up, decide together when your next such catch-up will be and then honor your time commitment and sign off promptly. (Unless your friend is having some sort of crisis, in which case it's good that you got in touch anyway.) Hang up and enjoy that little glow of well-being.

# United Women in Faith CEO Harriett Jane Olson to Retire in Spring 2023

**Oct. 13, 2022, New York, New York:** United Women in Faith General Secretary and CEO Harriett Jane Olson announced her planned retirement in the spring of 2023 in a closed session of the board's annual meeting, held virtually Oct. 7-8.



Ms. Olson took the helm of what was then the Women's Division of the General Board of Global Ministries in 2007 and began a 15-year tenure marked by programmatic and structural innovations and bold changes to strengthen the organization and position it for a future of growth and increased impact.

"What a blessing it has been to speak and teach from this vantage point about the overflowing love of God and the abundance that God offers as I have focused on the spiritual growth, service and work for justice of our members and all who are touched by the work of United Women in Faith," Ms. Olson said. "We sang 'I Love to Tell the Story' at my first board meeting, and we have been singing it and living it out ever since."

Ms. Olson began her tenure with internal innovations, introducing more flexible organizing structures that required fewer local, district, and conference officers, empowering members to customize their respective organizations to best suit their context. In 2010 the organization reconnected with some of its historic work, including National Mission Institutions and the Deaconess/Home Missioner community and took on the tag line "turning faith, hope and love into action on behalf of women, children and youth" to describe its work.

Under Ms. Olson's leadership the national body, which was already self-funded and self-governing, became an autonomous agency within The United Methodist Church in 2012 when the General Conference approved its separation from Global Ministries after operating as a part of the denomination's mission board for more than 70 years.

The organization also took a step toward regionalization in that year, as the term "national office" was used to describe the former Women's Division. In 2015 Ms. Olson led the organization in launching a 150<sup>th</sup> anniversary celebration including the creation of The Legacy Endowment Fund designed to cover the core expenses of mission.

And in 2022, Ms. Olson ushered in a broad refreshing of the organization's brand that opened opportunities for women to join and participate through an online All Access National Membership option and that introduced the new name United Women in Faith, making clear the organization's lifetime open door to women within and beyond The United Methodist Church.

Programmatically, during Ms. Olson's tenure the organization's popular Schools of Christian Mission was updated to the 21<sup>st</sup> century *Mission u* program. The program now offers annual mission studies for adult, children, and youth focusing on a single, Bible-based, justice-oriented theme and are easily adaptable for use in small or large groups, intergenerational studies, vacation Bible schools, and other venues.



Ms. Olson has represented United Women in Faith through leadership in ecumenical organizations by being a board member of Church World Service (twice) and as a representative at the World Council of Churches. She has also spoken in forums around the United Nations raising concerns of women and children and peace.

Prior to heading United Women in Faith, Ms. Olson served from 1996-2007 at the United Methodist Publishing House in Nashville as senior vice president for publishing, responsible for the development, production, and trade distribution of resources from Abingdon Press, Cokesbury and Kingwood Books. An attorney and graduate of Harvard Law School, Ms. Olson was a partner at the Pitney, Hardin, Kipp, and Szuch law firm of Morristown, New Jersey, specializing in environmental law from 1983-1996.

From 1988-96, Ms. Olson was a director of the United Methodist General Board of Discipleship and was a delegate to the 1988, 1992, and 1996 General Conferences. She was elected to the postponed 2020 General Conference by the merged Greater New Jersey Conference. She served on many committees of the former Northern New Jersey Conference, including the conference's task force on sexual harassment policy and Commission on the Status and Role of Women. She was instrumental in teaching and interpreting the landmark *Words That Hurt, Word That Heal* document that identified the need to use inclusive language in the church.




