#### President's Message

I recently attended an exciting Northeast Jurisdiction United Women in Faith meeting where they asked, "What is your why?" For example,



#### Greater New Jersey United Women in Faith Legislative Events Task Force

In our March issue of <u>Voices of Purpose</u>, we announced the creation of a Special Interest Group for GNJUWF for legislative visit plans. The group has been officially named the <u>Legislative Events Task Force</u> and plans for a September visit to our New Jersey legislators in Trenton, New Jersey have fared very well. We report a synopsis of our progress to date in this article and will announce our success in the September 2023 newsletter issue.

Due to legislative time constraints, our September 2023 legislative discussions will consist of only three topics and do not preclude future visits whenever state issues demand. All topics will include current New Jersey bills that address the issues. The current agenda for our planned NJ legislative visit follows.

- GNJUWF Introduction Susan Zahorbenski, President
  - o Summary of United Women in Faith mission and purpose.
- Gun Control/Violence Sara Joslin
  - NJ district and national issues that include school gun violence, civilian purchase of assault weapons, and tightening NJ gun regulations.
- Climate Justice Mary Bland
  - Environmental plans that disproportionately impact disadvantaged groups/communities such as selective offshore wind power for electric heating and transportation, minimizing wind turbine burdens on commercial fishermen, jobs forecasted to build offshore wind farms, and continued research to protect our wildlife.
- School-to-Prison Pipeline Carolyn Pendleton
  - Zero-tolerance policies, suspension equity, alternatives/solutions, and bills recommending tactics for change.
- Conclusion and Q&A Session Grace Rapp
- Program Coordinator Joyce Pratt

Each of the presentations will end by asking our legislators the question, "What are your plans to address these issues?"

The Legislative Events Task Force hopes and prays for other members to join us for a powerful showing of GNJUWF members pursuing social action to ensure our legislators consider resolutions and bills that will benefit our society.

## US Supreme Court upholds Native American adoptions law (ICWA). June 15, 2023



The Indian Child Welfare Act of 1978 (ICWA, enacted November 8, 1978) is a <u>United States federal law</u> that governs <u>jurisdiction</u> over the removal of <u>American Indian</u> children from their families in custody, foster care and adoption cases.

It gives <u>tribal governments</u> exclusive jurisdiction over children who reside on, or are domiciled on a <u>reservation</u>. It gives concurrent, but presumptive jurisdiction over foster care placement proceedings for Native American children who do not live on the reservation.

In a 7-2 decision, the US Supreme Court ruled that Native American families should continue to have priority in adoption or foster care of Native American children, thus preserving the 1978 Indian Child Welfare Act (ICWA). The decision rejected a challenge by a white Texas couple who argued the law was a form of racial discrimination. Native American leaders argued the law helps protect their traditions and cultures and treats Native Americans as a political class, rather than a racial group.

The ICWA was put in placed 45 years ago to address a widely spread practice in the 19<sup>th</sup> Century by the US government and states of taking children from their Native American families in order to assimilate them into white America.

Assault Weapons Ban of 2022. The U.S. House of Representatives passed the Assault Weapons Ban of 2022 on July 29, 2022. The bill makes it a crime to knowingly import, sell, manufacture, transfer, or possess a semiautomatic assault weapon (SAW) or large capacity ammunition feeding devise (LCAFD). The bill was received in the Senate on August 1, 2022, Read twice and referred to the Committee on the Judiciary. #### What is "Climate Justice?"

It begins with the idea that the adverse impacts of a warming climate are not felt equitably among people.

Climate change, an inherently social issue, can upset anyone's daily life in countless ways. But not all climate impacts are created equal or distributed equally. From extreme weather to rising sea levels, the effects of climate change often have disproportionate effects on historically marginalized or underserved communities.

"Climate justice" is a term, and more than that a movement, that acknowledges climate change can have differing social, economic, public health, and other adverse impacts on underprivileged populations. Advocates for climate justice are striving to have these inequities addressed head-on through long-term mitigation and adaptation strategies.

Three key factors to consider in thinking about climate justice:

- 1) Climate justice begins with recognizing key groups are differently affected by climate change.
- 2) Climate impacts can exacerbate inequitable social conditions.
- 3) Momentum is building for climate justice solutions.

In the end, there is no single way to define, let alone champion, climate justice. But in combination with other current social justice movements, many experts see climate justice becoming an increasingly significant component of overall concerns raised by climate change.




