Fireworks

I was recently notified by the School District they now have rubber roofing and solar panels on areas of GCHS and Coolidge. This presents a serious problem with the future location of our fireworks display due to the proximity of these buildings to the launching area. Fortunately, we have this information now, so we have more time to look at a possible solution.

Upon receiving this information, I notified Melrose Pyrotechnics to assist in determining a new possible launch area. The suggested new location is to launch the fireworks near the outfield of diamond #2. This location requires the carnival to be moved onto 29th Street. We are continuing to explore other possible options.
