Morrilton Fire Department and Conway County Fire Department Automatic Aid Agreement

Automatic Aid:

A program designed to provide and/or receive assistance from the closest available resource, irrespective of municipal boundaries.

Intent:

- Persons experiencing the emergency will receive a seamless service through the elimination of artificial service boundaries.
- The implementation of an automatic aid program can enhance the level of public safety.
- The concept of automatically dispatching the closest available assistance could reduce the critical element of time between the commencement of a fire or rescue and the application of an extinguishing agent to the fire and/or initiation of emergency operations.
- Life, property, and environmental losses may be substantially reduced.
- Public and firefighter safety will be improved.
- The persons living or working in the defined areas will all stand to receive an improved level of service.

Agreement:

For the purpose of this agreement, and automatic aid agreement means any agreement under which.

- A municipality agrees to ensure the provision of an initial response to fire and rescues
 that may occur outside the municipality where a fire department in the municipality is
 capable of responding more quickly than a fire department outside the municipality: or
- 2. a municipality agrees to ensure the provision of a supplemental response to fires and rescues that may occur outside the municipality where a fire department situated in the municipality is capable of providing the quickest supplemental response to fires or rescues occurring in areas outside the municipality; or
- 3. a fire department situated outside a municipality agrees to provide initial response to fire that may occur inside a municipality where a fire department situated outside the municipality may be capable of responding more quickly than a department situated within the municipality; or
- 4. A fire department situated outside a municipality agrees to provide supplemental response to fires that may occur inside the municipality where a fire department situated in the municipality may require specialized equipment not available in the municipality.

Response Operations:

For purpose of the agreement, response operations agreement means any agreement under which:

- A municipality or other department agrees to ensure the use of universal standard operation procedure in regard to fire and rescue training and tactics.
- A municipality or other department agrees to ensure the use of the unified command system during fire and rescue incidents.
- A municipality or other department agrees to ensure the use of a common fire ground communication frequency.

Response Criteria:

The City of Morrilton Fire Department:

The department shall provide a minimum of one Engine Company (driver and four firefighters) and one command officer for structure fire and rescue alarms, excluding automatic alarm systems, within the designated automatic aid area.

Additional resources, equipment, or personnel above the minimum shall require authorizing party approval.

Upon arrival, following incident size-up, the Incident Commander(IC) shall have the authority to cancel responding units.

The Conway Country Fire Department:

The department shall provide a minimum of one Engine Company (driver and four firefighters) and one command officer for structure fire alarms, excluding automatic alarm systems, within the designated automatic aid area, and tanker shuttle operations within the designated automatic aid tanker shuttle area.

Additional resources, equipment, or personnel above the minimum shall require authorizing party approval.

Upon arrival, following incident size-up, the Incident Commander (IC) shall have the authority to cancel responding units.

Responding Areas:

For purposes of this agreement, response area is the geographic area and/or physical location in which a municipality or other department shall provide or receive automatic aid

The City of Morrilton shall provide automatic aid in the specified area of the Conway County Fire Department (CCFD) Districts as follows:

Kenwood District;

Beginning at the City Limits of the City of Morrilton on U.S. hwy 964 westward to the Point Remove Creek and eastward along Monastery Ridge Road to the Morrilton City Limits.

Beginning at the City Limits of the City of Morrilton on Ark hwy 113 westward to 2153 Hwy 113.

Overcup District:

Beginning at the City Limits of the City of Morrilton along Ark hwy 9 on both sides to Cothern Estates, then northward to Lake Overcup, including Cothern Estates Subdivision, then westward along the south shore of Lake Overcup to Ark Hwy 95, them southward along Ark Hwy 95 to Monastery Ridge Road, then westward along Monastery Ridge Road to McKennon Road, then along McKennon Road and Family Mission Road to the Morrilton City Limits.

Beginning at the City Limits of the City of Morrilton along Ark Hwy 287 on both sides of the Hwy to Deerfield Subdivision. Includes Abbey Lane and Deerfield Subdivisions. Rev. 4/14/15

Sardis District:

Beginning at the City Limit of the City of Morrilton southward to Bruce Oakley Port. Beginning at the City Limit of the City of Morrilton on Blue Diamond Drive eastward to the end of Blue Diamond Drive and the end of Trison Drive.

The Conway County Fire Department Districts shall provide automatic aid in the specified areas in the City of Morrilton:

Sardis District:

Along Sardis Road in Windy Meadow, Golden Plains, and Taylor Creek Subdivisions, Airport Road at the Morrilton Municipal Airport, and along Sandtown Road from Ark Hwy 9 to the City Limits of the City of Morrilton at the intersection with Sandy road.

Overcup, Kenwood, and Sardis Districts:

Tanker shuttle operations on Carruthers Hill area including E. Childress street, Carruthers Drive, Jonathon Drive, Ashley Drive, and Kristen Taylor Drive.

The City of Morrilton and the Conway County Fire Department Districts hereby agree to automatic aid, in concept and intent, recognizing the benefit of automatic aid to both the City of Morrilton and the Conway County Fire Department Districts affected.

Additionally, the City of Morrilton and the Conway County Fire Department agree to the provisions as outlined in the operational, procedural, and response criteria set forth in this agreement.

In the event that the agency providing automatic aid is unavailable due to an existing fire, rescue or other emergency within its primary jurisdiction or apparatus are out of service due to mechanical circumstances, the agency providing assistant is not obligated to responding to the agency receiving assistance.

Termination of Agreement:

This agreement may be terminated, in while or in part, by written notice to terminate given by certified mail with postage prepaid, addressed, if by the City of Morrilton, to Conway County Administrative Fire Board, to 117 South Moose Street, Morrilton, Arkansas, and if by the Conway County Administrative Fire Board, to Office of the City Clerk, City Hall, 210 North Moose Street, Morrilton, Arkansas 30 days prior to date of termination.
