MDS Section M Guidance effective October 1, 2023

Skin changes at the end of life (SCALE) also referred to as Kennedy Terminal Ulcers (KTUs) and Skin Failure are not primarily caused by pressure and are not coded in Section M of the MDS.

Objectives:

- To discuss the new guidance from CMS for Section M of the MDS related to SCALE, KTUs and Skin Failure
- To distinguish end-of-life associated pathophysiology as the primary causation of skin and wound changes versus other primary causes such as pressure, friction, shear and moisture
- To explain the clinical, regulatory and legal implications of the new guidance from CMS for Section M of the MDS

Description

A new, critical guidance for CMS for Section M on the MDS kicked in on October 1, 2023 that will immediately impact wound and skin care in long term care and has ramifications across the continuum of care. This webinar will discuss clinical, regulatory and legal implications of the new guidance not to code SCALE, TKUs and Skin Failure in Section M. Case studies will be used by the panel to discuss the issues.
