Did you know that violation of some regulations could result in civil penalties up to \$27,500 per day and possible criminal penalties of up to \$250,000 and 15 years in prison?

Some of the regulators will be very familiar to you like the "big three" federal OSHA, EPA and the DOT. Did you know most states also have a state-run agency for these as well? The difference between the information side of a regulatory agency versus the enforcement side of the same agency will be explained. How to prepare and respond to a surprise or scheduled audit and how to respond when compliance issues are identified.

During this talk we will identify how your employees can play a vital role in the success of being ready for visits from regulators. How to get buy-in, by including them on committees or teams. This will be a good platform for employees to identify issues that need to be addressed by management and if needed policies and procedures can be written and issues be corrected.

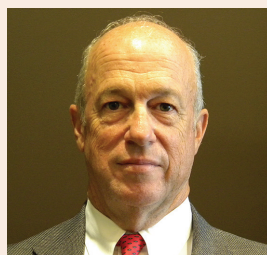
