Chief Jerry Streich is an International Speaker and Trainer working in the U.S. and Africa. For over 32 years he has served his country, state and community responding to disasters. One of his biggest challenges however, has been dealing with PEOPLE who continually disrupt the daily operation of the organization. In fact, one case nearly put him over the edge as he was bullied and personally threatened. This case made headline news and the results are shocking.

The topic of workplace violence is on a front page everyday across this country. Some people are literally afraid to go to work! As leaders, especially in one of the most elite fields in the world, why do we allow this type of behavior in our workplace? Maybe we are part of the problem? We are certainly part of the solution.

In this 4-hour presentation, Streich leads attendees through the history of the fire service to regain the important role we have. He then moves into defining a "difficult person" and how our generational differences (beliefs, work ethic, etc.) require frequent adjusting to tune the elite team we need to become. He tells his story that nearly ended his career and shows how to resolve conflict and bad behavior from those we deal with.

Streich is an impactful speaker who brings fun into the presentation and holds the audience's attention by getting them involved in the conversation. We all have a story to tell.
