We require that all teachers, whether the home teacher or tutor, hold a bachelor's degree as required by our accrediting agency. The Noah Webster Center sponsors 8 hours of informational seminars for tutors/mentors who have not completed a college degree, and requires all tutors/mentors not possessing college degrees to complete at least 8 clock hours of this instruction in order to be registered as an instructor.

TESTING CRITERIA

I understand that the Noah Webster Center requires proctored quarterly testing to be performed in the following manner.

Testing is an important part of teaching. It is how we measure our progress and that of the student. For purposes of an accredited transcript, **tests need to represent the retained knowledge of the student**. Therefore, while open-book tests may be used in a normal home school routine, the Noah Webster Center requires that the quarterly supervised tests are without books or notes. In the instance of a test requiring the **use** of several formulas, a 3x5 note card list of the formulas may be allowed. In Geometry, Algebra 2, Chemistry and Pre-Calculus the use of a calculator or graphing calculator such as the TI-83 is acceptable. No other use of calculators or other helps is allowed.

I understand that the Noah Webster Center has determined a schedule of certain times for proctored tests, and the test schedule requires that I schedule the progress of my class(es) for test periods within these windows for continuity of the program. I also understand the requirement for providing grade history and clock hours for each course.
