- 1) Rider/visitor is responsible for full and complete insurance coverage on his/her horse, personal property and him/herself and their visitors or any other person or animal accompanying them.
- 2) Rider/visitor understands that there are risks in and around equine activities and that there is no insurance coverage and/or do not possess assets to cover any injuries or property.
- 3) Rider/visitor agrees to assume any and all risks involved in or arising from rider's use of or presence upon owner and manager's property and facilities including, without limitation but not limited to: the risks of death, bodily injury- temporary and/or permanent, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire and/or explosion, the unavailability of emergency medical care, and/or the negligence and/or deliberate act of another person.
- 4) Rider/visitor agrees to hold owner and manager, officers, volunteers, guests, and any property and animal and all affiliates completely harmless and not liable and releases them from liability whatsoever and agrees not to sue them in connection with injury or damages occurring out of the use of owner/manager's property and animals. If a suit is commenced, person initiating suit is responsible for owners attorney fees and costs.
- 5) Rider/visitor understands the following warning, which is posted in Tack Room on the owner/manager's property which reads as follows:  
The owner of the property does not carry insurance for and does not have assets to cover any injuries or property.
