In order to carry out our responsibility, we need your cooperation in affecting programs for the safety of all stables. THE ENTIRE STABLE AREA IS DESIGNATED AS A HAZARDOUS AREA. PARKING IS NOT PERMITTED - TOW AWAY ZONE.

Fire lanes must be maintained unobstructed in order that access is not unduly difficult for large fire trucks. Also, this area does not meet state and local criteria for recreational vehicle parking. FIRE LANES are considered to be tow-away zones. Staff has been instructed to summon tow trucks as necessary. Unauthorized use of the lighting fixtures provided in the stable for water heaters, heating lamps, space heaters, etc. will result in the removal of your appliance. Devices removed will be held at the Horse Show Office until your departure. Smoking or open flame devices are not permitted within the entire horse show grounds. Please keep flammable decorations to a minimum in your tack room. We recommend that you bring a garden hose available for attachment to the water spigots provided.

Equine Health Entry Requirements

Protecting the health of your horse and other horses at the Portuguese Bend National Horse Show is of the utmost importance. We are implementing Required Biosecurity Measures to decrease the risk of introduction and/or spread of contagious or infectious disease at our shows.

Horses must arrive only between the hours of 8 am - 5 pm daily. Off-hours arrival must obtain permission from Show Management 24 hours prior to arrival.

UPON ARRIVAL TO ERNIE HOWLETT PARK, ALL HORSES MUST HAVE/PROVIDE:

TRAINER DECLARATION OF HEALTH (REQUIRED):

Trainer must sign the Trainer Health Declaration form to confirm that all horses entering the show grounds have been in good health with no sign of infectious disease and have not had a fever above 101.5°F within the last 14 days. Signing this form confirms that the horses listed are not demonstrating any signs of EHV-1, have not had any known exposure to EHV-1 in 21 days, and are not coming from a property with known EHV-1 positive cases.

USEF VACCINATION RECORD (REQUIRED):

The USEF Vaccination Record form must be completed. The following information must be included: date of vaccination; place of vaccination; vaccine name; vaccine batch; and vaccine route mode. Form must be signed and stamped by attending veterinarian.

Within 6 months (180 days) of each show: **Equine Influenza**

Within 6 months (180 days) of each show **EHV 1 and EHV 4**

If a vaccination will expire during one of the shows, the horse must receive its new vaccination prior to being issued a competition number for that show.

7 DAY TEMPERATURE LOG (REQUIRED):

A 7 day temperature log, with temperatures taken twice per day, must be submitted for each horse 24 hours prior to arrival.

VET EVALUATION/STATEMENT OF HEALTH (REQUIRED):

A signed letter must be submitted by attending veterinarian stating that each horse is in good health and with no sign of infectious disease. This letter should confirm that the horses are not demonstrating any signs of EHV-1, have not had any known exposure to EHV-1 positive cases. **EVALUATION MUST BE CONDUCTED WITHIN 14 DAYS OF ARRIVAL**

PRESENTATION OF HEALTH REQUIREMENTS

(REQUIRED):

The Equine Health Requirements are Required for all horses entering the Show Grounds both Showing and Non-Showing.

These documents must be in the Show Office before any competition numbers will be issued. In addition, random checks for Equine Health Requirements will occur. Be sure to keep a copy of all of your horse's Equine Health Requirements in an easily accessible spot (in your tack room or tack bunk, tack trunk, truck or trailer) to ensure you can comply with this requirement. The results on all required papers must indicate the horse's registered (show) name.

Any horse not accompanied by these documents will be directed to the Show Veterinarian to obtain the required documents and/or vaccinations, and/or will be placed in quarantined stabling until the proper documents are obtained. Any horse showing signs of fever/illness/stress is subject to examination by Officials and/or the Show Veterinarian, who may at their sole discretion, place the horse in quarantined stabling or take further action if deemed necessary.

These forms are required to bring a horse to the Portuguese Bend National Horse Show and must be submitted 24 hours before or upon arrival. These signed forms will be considered truthful and binding. In the event of any of these protocols being disregarded, we will refuse further entries from all related horses and we will inform USEF for further disciplinary action. Noncompliance with these protocols will result in penalties imposed by USEF on trainers and owners as well as competitions that knowingly permit non-compliant horses on the showgrounds. In order for an AFFECTED/POSSIBLY EXPOSED horse to be eligible to return to USEF competition, the following requirements must be met:

Two negative PCR tests within 14 days after leaving the facility with EHV-1 cases, one at day 7 and one at day 14

OR

One negative PCR test within 21 days after leaving the facility with EHV-1 cases at day 21

OR

Horse must be quarantined for 28 days after leaving the facility with EHV-1 cases.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and Portuguese Bend National HS ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

In consideration for entry upon the SHOW GROUND FACILITIES of the COMPETITION, the undersigned on behalf of myself, my trainers, instructors, coaches, clients, agents, employees, grooms, invitees, representatives, assigns, executors, heirs, independent contractors (including but not limited to veterinarians, farriers, masseuses, chiropractors, therapists, braiders, or shippers), and, if applicable, on behalf of my minor child or children (hereinafter collectively referred to as "I") agrees:

I agree that COMPETITION as used in this entry blank, in the prize list and in the USEF rules means, Portuguese Bend National Horse Show, each and every class and/or event conducted and ALL ACTIVITIES that I undertake AT ANY TIME and for any purpose upon entry of the SHOW GROUND FACILITIES including any horse which is on the SHOW GROUND FACILITIES for my use, in my control or at my request. I further agree that COMPETITION includes the entire week of the horse show including the time horses and/or people are allowed to enter to set up, stable and/or conduct business whether its expressly and/or specifically related to the horse show and classes being conducted/held that week through and including the time all horses and/or people vacate the SHOW GROUND FACILITIES.

I agree that this Release of Liability includes any horse that I have asked to come onto the SHOW GROUND FACILITIES for any purpose, and/or is in my control and/or custody and regardless whether the horse is being stabled at the SHOW GROUND FACILITIES and/or competing in the COMPETITION.

I agree that "RELEASED PARTIES" means the "Competition" known as Portuguese Bend National Horse Show and "Horse Show Management" and/or "Competition Management" as referenced in the Prize List, The Federation Licensee, Peninsula Committee Children's Hospital, Equestrian Enterprises, Inc., The City of Rolling Hills Estates and each of their officers, directors, managers, members, owners, shareholders, employees, representatives, agents, subsidiaries, volunteers, officials, affiliated and associated persons, companies and organizations, assigns and entities or organizations as may now or hereafter be constituted, that own, are related to or manage the property owned by such entities.

I agree that SHOW GROUND FACILITIES mean the Ernie Howlett Park including but not limited to all improvements, structures (permanent or temporary), buildings, tents, stalls, fixtures (including but not limited to all jumps and related equipment), rings (and the footing therein) located on the premises and/or provided by RELEASED PARTIES during the COMPETITION.

I agree that if I am not a member of the Federation that I will abide by all rules and regulations of the Federation. I agree that the rules of the Prize List are incorporated as if set forth herein.

RELEASE AND WAIVER OF CLAIMS: I hereby fully and forever release, waive and discharge the RELEASED PARTIES and each of them who are or might be liable in any way from any and all claims, demands, actions, causes of actions, liabilities of any kind which I may or might have against RELEASED PARTIES or any of them, arising from or by reason of any and all known and unknown, foreseen or unforeseen bodily and personal injuries, damage to property, injury to horse and any consequences thereof, which I may sustain due to the ordinary negligence of RELEASED PARTIES; I further agree that except for the gross negligence or willful misconduct of the RELEASED PARTIES, I SHALL NOT SUE or bring any legal action, claim, and/or demand against for any economic and non-economic losses due to bodily injury, death, property damage and/or injury to any horse in relation to the SHOW GROUND FACILITIES and/or the operation and conduct of the COMPETITION. I agree this RELEASE INCLUDES ALL ACTIVITIES I PARTICIPATE IN AND ALL AREAS OF THE SHOW GROUND FACILITIES as defined above. This release also includes all activities I conduct at the SHOW GROUND FACILITIES and includes all times that I am at the SHOW GROUND FACILITIES no matter what the purpose and/or activity being undertaken.

HOLD HARMLESS: I hereby agree to defend, indemnify and hold harmless RELEASED PARTIES from and against any and all claims, liabilities, loss, damages, demands, actions, causes of action, including attorneys' fees, cost and expenses of any kind, which may be made against them, or any of them, which arise out of the active or passive negligence of RELEASED PARTIES while either I or any horse at my request or in my control is/was on the SHOW GROUND FACILITIES and/or participating in the COMPETITION. I agree to defend RELEASED PARTIES, at my expense, regardless if RELEASED PARTIES are negligent or not.

ASSUMPTION OF RISK: I hereby acknowledge and assume the risk that equestrian activity, including jumping, is very dangerous and involves the risk of serious injury and/or death and/or property damage. I expressly acknowledge that injuries may be compounded or increased by negligent maintenance of the SHOW GROUND FACILITIES, faulty or improperly secured equipment, improper supervision or compliance with Federation rules and regulations. Acts of God and negligent rescue operations or procedures of RELEASED PARTIES and negligent handling of horses and independent operations by trainers, riders and/or boarders who use the SHOW GROUND FACILITIES or others who are not affiliated with RELEASED PARTIES. I acknowledge that horses can be injured while being ridden, groomed, stabled, walked and/or exercised and I expressly assume the risk of injury to any horse under my control and/or custody or on the SHOW GROUND FACILITIES at my request.

This agreement shall be governed by the laws of the State of California with respect to all RELEASED PARTIES, except for the Federation as set forth on page one. I agree this Release extends to all acts of ordinary negligence of RELEASED PARTIES and is intended to be as broad and inclusive as permitted by law. If any portion of this Release and/or Entry Blank is held invalid, it is agreed that the balance shall continue in full legal force and effect. I have not relied on any oral representations or statements made that are contrary to or modify the above Release or warnings. I agree that by signing the front page (page 1) of this Entry Blank that I am bound by the Release, waiver and warnings contained herein and that both sides/pages constitute one incorporated agreement. I agree I have the express authority to sign this entry blank/Release on behalf of the owner and/or rider.



RULES AND GENERAL INFORMATION

The PORTUGUESE BEND NATIONAL HORSE SHOW is covered by the rules and specifications of the current USEF Rule Book and will be conducted and judged in accordance therewith.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes: (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF Introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

1. ENTRY PROCEDURES

- a) For each horse entered, send only a \$300 deposit.
- b) Send with your completely filled out entry blank on or before the closing date of entries. NO NUMBERS WILL BE ISSUED WITHOUT A SIGNED OPEN CHECK OR CREDIT CARD INFORMATION.
- c) Entry blanks must be filled out completely, including all classes, signatures and organization membership numbers; incomplete entry blanks may be returned.
- d) If entry blanks are postmarked on or before the closing date of entries, and are properly filled out.
- e) **LATE OR INCOMPLETE ENTRIES WILL BE CHARGED \$75!**
- f) DO NOT make entries from the time schedule. Consult the index to classes. The schedule is subject to change after the close of entries. Therefore, upon arrival at the show, be sure to check the time schedule in the Show Office or Ringradar.com.

2. POST ENTRIES AND/OR CHANGES

Care should be taken to enter each horse in its proper division or class. Exhibitors are responsible for their errors and those of their agents in making out entry blanks. In all classes the description in the entry blank must fully identify the horse. The word "entry" shall not be accepted. Misrepresentations of a horse's name, eligibility for a class or any other information on the entry blank or substitution, without proper procedure for scratching and making a new entry for any horse, shall result in the exhibitor's forfeiture of any trophy, ribbon, and/or cash prize won by such misrepresentation, and subject exhibitor to further penalty.

3. ADDS & SCRATCHES

All classes must be added the day before by 4pm. Same day adds will not be accepted except by management approval. All other scratched classes will be credited, provided the class is scratched prior to the start of the class in the show office. Horses and/or riders who go in a class without entering will be charged an *additional* \$20.

4. ENTRY BLANK MUST:

LIMITATIONS ON ENTRIES

Management reserves the right to limit entries in any class per GR915. Refused entries will be returned. **Post entries will not be allowed unless time permits.**

5. REFUNDS

- a) Show scratches received before the close of entries receive a full refund, less any credit card fees.
- b) Show scratches received after the close of entries through August 10, 2026 will forfeit the Hunter/Jumper fee of \$75 , however will receive a full refund on the stall fee.
- c) Show scratches after August 11, 2026 through the start of the show will forfeit the Hunter/Jumper fee of \$75, the stall fee and will be responsible for any fee/bedding ordered.

. **TRANSFERS & SUBSTITUTIONS**

The transfer of horses and/or riders from one class or division to another will be allowed under the following circumstances:

- a) The Horse Show Office is notified the day preceding the transfer.
- b) Full credit will be given for the scratched class or division, but post entries must be paid for on all added classes.
- c) No refund will be given if the horse does not use up his transfer credit.

7. **PRIZES**

All class winners will receive a trophy and ribbons through 6th place in addition to any prize money. Prize money will pay to 6th place: 30%, 22%, 16%, 13%, 11%, 8% excepting special classes. Prize money will be paid by check to owners within four weeks of the show's conclusion. **NO PRIZE MONEY WILL BE MAILED UNLESS THE OWNER'S SOCIAL SECURITY NUMBER IS LISTED ON THE ENTRY BLANK.**

8. **RESPONSIBILITY AND PAYMENT OF SERVICES & SUPPLIES**

All owners and exhibitors will be held responsible for any damage incurred by them, their agents or employees to stalls, buildings and other properties on the show grounds and shall be billed accordingly. All bills for veterinary, farrier services and feed are due and payable during the show. The management and Board of Directors and/or Horse Show Committee reserve the right to deduct any unpaid veterinary, farrier, and feed bills from premium money due the exhibitor. Any exhibitor not meeting his obligations to the official veterinarian, farrier and feed man will be termed an undesirable exhibitor and entry from that exhibitor will not be accepted at subsequent shows.

9. **MINOR EXHIBITORS**

Parents or guardians of a minor exhibitor shall hold K/A Productions, PCCH, and Show management harmless for injury to such minor. No child's entry will be accepted unless their entry blank is signed by a parent or guardian. The signature of instructors, agents, or other unrelated persons will not be acceptable.

10. **MANAGEMENT**

The Horse Show Management reserves the right to itself to interpret all questions and conditions in regards to or arising out of an incident at the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by the Horse Show Management, their decision to be final. The Horse Show Management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to cancel or combine any unfilled classes or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule.

11. **JUDGES**

It is the purpose of the Management to run the Horse Show in the highest possible level of sportsmanship. The Management uses the upmost care to select judges with broad experience and knowledge. The Judges' decisions in the show ring are their own responsibility and the Management accepts no responsibility for those decisions.

12. **EQUINE HEALTH REQUIREMENTS**

Equine Health Requirements will be enforced. All horses (competing or not) that enter the grounds are required to present the Required Health Entry Requirements, including the Event Participation Declaration and Proof of Vaccination. Per GR845 Equine Vaccination Rule: At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management.



13. STABLING

Stalls, whether occupied by horses, feed or tack will be available for \$300 each prior to the close of entries and \$325 each after, no first bedding is included. Stalls are of wood or canvas construction 9.6' x 9.6' with doors. Stalls will be erected on the dirt/gravel parking lot of Ernie Howlett Park. Horses must be washed in designated wash racks and not in the barn aisles. **NO STRAW BEDDING WILL BE PERMITTED AND ONLY SHAVINGS WILL BE PERMITTED.**

IMPORTANT NOTICE!

Only 1 tack or groom stall will be allotted for every five horses entered, due to extremely limited stabling. Groom's Parking Passes will be given for every five horses entered. Passes will be numbered and recorded at the horse show office.

14. DAMAGES

Owner and Exhibitors shall be held responsible for damage caused by them, their agents, or employees to stalls, buildings and other properties on the show grounds, and shall be billed accordingly.

15. HORSE RECORDING REQUIREMENTS AND MICROCHIP VERIFICATION

All competing horses must be registered with the USHJA (exception – horses entered only in Opportunity classes). In order to be eligible for HOTY awards and/or Zone awards, horses must be recorded with USEF annually or for life. For on-line horse recording go to:

MICROCHIP VERIFICATION: All horses competing in classes that require USHJA horse registration must provide a microchip number that verifies their animal's identity in order to compete for points, money won or be eligible for Federation and/or USHJA programs and awards where horses are required to be recorded or registered. A microchip used to verify identity must be a fifteen-digit ISO compliant 11784/11785 chip and be implanted in the nuchal ligament of the animal. All horses that are competing in classes which require USHJA registration which are not microchipped will be ineligible to compete in Federation licensed competitions, Exceptions: USHJA Outreach and those activities enumerated in GR901.9.

16. VACCINATION REQUIREMENTS

Per USEF GR845 12/1/15 All horses entering the show grounds must have proof of vaccinations against Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management.

17. CHAMPION AND RESERVE CHAMPION AWARDS

In all Hunter Championships, the title shall be awarded to two of the four horses which have acquired the most points over fences. In addition to these points, only these four horses shall receive full points for ribbons won in under saddle classes. USEF & PCHA Show Championships shall be awarded on a point basis of 10, 6, 4, 2, 1, & ½.

18. FEED AND BEDDING

Hay and shavings will be available at the Horse Show. Feed orders must be made by 12 noon each day for same day delivery. **FOR PRE-SHOW ORDERS:** No outside commercial feed/bedding deliveries are allowed, but exhibitors may bring their own. Feed and Bedding is not available on site during the show. All orders **MUST** be placed with the Show Office by 12 noon for same day delivery. No email or text orders during the show.

19. RETURNED CHECKS

Checks returned by the bank for any reason are regarded as a most serious offense and will be handled according to the following procedure: **A 10% PENALTY WILL BE ASSESSED FOR EVERY RETURNED CHECK! (MINIMUM OF \$25)** Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be turned in to the USEF and the PCHA for further disciplinary action.

20. CONDITION OF ENTRY AND ASSUMPTION OF RISK

Every horse entered for competition will be under the control of Horse Show Management, but the Horse Show Management will, in no case, be responsible for any loss or damage that may occur and it shall be a condition of entry that each exhibitor shall hold the Horse Show (competition) and its' officials, employees, directors, officers, Portuguese Bend National Horse Show, Peninsula Committee Children's Hospital, K/A Productions, Children's Hospital Los Angeles, the City of Rolling Hills Estates, and sponsoring entities harmless for any loss or accident to his/her horse, employees or equipment which may occur from sickness, fire or other cause.



By signing the entry blank, the Owner, Lessee, Trainer, Manager, Agent, Coach Driver, Handler, Vaultor or Longeur acknowledges that horseback riding, particularly jumping, is a dangerous activity and involves inherent risks that may cause serious injury, and in some cases death, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance, and expressly assumes all such inherent risks whether identified herein, in the entry blank or in the Federation Rules and Regulations. A horse, without warning or any apparent cause, can buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's foot, or push a person, all of which may cause the rider or observer to fall, be jolted, resulting in serious injury or death. A horse may also become loose and cause injury to the observer or rider or to another horse – a loose horse can run at a full gallop in a panic and run into objects, or persons or other horses.

The Show Ground Facilities are bordered by highways & roads and thus noise from the traffic and other sources occur that can and will cause a horse to unexpectedly spook and react quickly. **The Show Ground Facilities** contain roads and driveways that are traversed by cars, golf carts, tractors, trailers, and heavy equipment, all of which may spook a horse. The above warnings and risks are meant as an example of some of the risks that are inherent and may be encountered, but it is agreed this is not an exhaustive list and there are numerous additional conditions, and/or events that may result in injuries while participating in the Competition and/or being present on the **Show Ground Facilities**.

21. UNPAID CHARGES/ UNCOLLECTED FUNDS

All accounts not settled by 5:00 pm on the last day of competition of the competition week will be closed out by the official show secretary using the payment information provided. All persons issuing returned check and/or declined credit cards will have ten days to settle their account, with cash or cash equivalent (including a \$50 penalty) or will be turned over to USEF & PCHA for disciplinary action.

22. CLOSED RINGS

Show arenas are closed at all times when not being used for classes or warm-up sessions. VIOLATIONS of the above WILL be considered cause for elimination from the show and/or a \$100 fine.

23. COURSES

Courses may consist of any combination of the following: brush, gates, oxers, post & rails, water, liverpools, ditch, walls, panels, banks, and coops. The Horse Show Management reserves the right to adjust fence heights or spreads as competition warrants.

24. NUMBERS

Management will provide a number card for each competitor which shall be worn on the rider's back, clearly visible to the judge at all times when in competition. Riders wearing the wrong number, or no number at all, MAY be eliminated from the class by the judges.

25. CONFLICTS

It is the intention of management to avoid holding rings to wait for horses and/or riders. Competitors with conflicts must arrange their jumping order with the starters so that they will not hold up a class. Starters have the authority to scratch competitors who are not timely. Trainer conflicts are not considered legitimate conflicts.

26. DOGS!!!

Dogs are a serious safety and health problem at a horse show. All exhibitors are urged to leave their dogs at home.

Management reserves the right to call Animal Control if necessary. **ALL DOGS AND OTHER PETS MUST BE ON LEASHES AT ALL TIMES!!!** USEF GR 1301.6 —Dog owners failing to comply with this rule may be subject to penalty under chapters 6 and 7, as well as issuance of warning cards.

27. MOTORIZED VEHICLES

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.



Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

28. RV SPACES

There are NO RV spaces available under any circumstances.

29. MEDICAL WASTE/SHARPS CONTAINERS

In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, Bio Hazardous Medical Waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste. Sharps must be placed in proper receptacles, which will be located in the stable area.

30. ARENAS

Footing in all warm-up areas and competition arenas is all-weather and/or sand mixture. Ring 1 - 125' x 260'
Ring 2 - 95' x 260'

31. HELMET RULE

It is compulsory for all persons at Federation licensed hunter, jumper or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear in compliance with the accepted testing standards published on the Federation's website. Protective headgear must carry the applicable quality testing tag and/or label. It must be properly fitted with harness secured. Exception: In Hunter or Jumper classes, adults may be allowed to remove their headgear while accepting prizes and during the National Anthem only: they must refasten their headgear prior to the lap of honor. It is compulsory for riders in Paso Fina classes, both open and breed restricted including Hunter Hack, where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear. It must be properly fitted with harness secured. A Show Committee, Competition Management, and Licensed Officials must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience.

32. PARKING

All exhibitors parking will be across Hawthorne Boulevard. Complimentary shuttle provided to stable area. Paid VIP parking WILL be available on a first-come basis.

33. NO SMOKING IS ALLOWED ON THE SHOW GROUNDS, AS ERNIE HOWLETT PARK IS A CITY PARK.

34. COMBINING/SPLITTING OF CLASSES: IN ALL "A" RATED HUNTER SECTIONS

Should entries warrant, all "A" rated hunter sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class in each section; therefore entries MUST be completed for "A" rated hunter divisions accordingly to be considered. Same day scratches and/or "no-shows" at the gate in all "A" rated hunter sections will forfeit their entry fee unless a Certificate from the Official Show Veterinarian vet scratch for the show is received by the official show secretary prior to the section in question. Should same day scratches or no-shows result in insufficient entries to keep sections split, sections will be combined. "Non-showing" fees will be assessed accordingly.

35. SAFE SPORT: REMINDER:

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies.
