

RESOLUTION OF THE VILLAGE OF AVOCA

THIS RESOLUTION FOR THE VILLAGE OF AVOCA made as of the 2nd day of March, 2021 (the “Effective Date”), by the Village of Avoca Board of Trustees, a municipal corporation, under and by virtue of the Laws of the State of New York, to include its property holdings being located wholly within the Village of Avoca, Town of Avoca, Steuben County, State of New York, and the Village of Avoca having municipal and ranging interest in the designation of public thoroughfares for use by the public for transportation, hereby pass this resolution to designate a public street wholly located within the Village of Avoca,;

WHEREAS, in the interest of the tax payers residing within the Village of Avoca and the general public to allow year-long access to the Highland Cemetery and the Avoca Central School Athletic complex, which is located on the east side of Salmon Creek, the Village of Avoca hereby designates and authorizes the establishment of East Avenue Extension, and;

WHEREAS, the Village of Avoca will hereby designate the existing public thoroughfare as East Avenue Extension from the following location:

- A. Beginning at the intersection of East Avenue and Ward Street in the Village of Avoca, East Avenue Extension shall be designated to run due East from this intersection for a total of 359 feet, as further defined and specified as,
 1. 170 feet from the intersection of East Avenue and Ward Street to the culvert running over Salmon Creek, and then shall continue due east another,
 2. 21 feet across the culvert over Salmon Creek located in the designated flood control plain maintained by the Army Corp of Engineers, and then shall continue due east another,
 3. 168 feet towards the Highland Cemetery, where the entrance is designated by the Stone Pillars located on each side of the roadway, which is the entrance to the Highland Cemetery where said East Avenue Extension shall be terminated at the main entrance to the cemetery.

WHEREAS, the Mayor for the Village of Avoca has presented this Resolution to the duly elected Village Board of Trustees for consideration, after consultation with the New York State Department of Transportation, as to allow and duly authorized the Village of Avoca Street Department to provide year long road maintenance to this designated Village Street as to allow public access to the Highland Cemetery and Avoca Central School athletic complex, and;

NOW, THEREFORE, IT IS HEREBY AUTHORIZED AND APPROVED, by the Avoca Village Board of Trustees:

1. The Village of Avoca Street Department will be designated and accept the responsibility for the maintenance and repair of the roadway and any bridge or culvert structure located within the designated area, and;
2. The Village of Avoca, as the local governing body, will also accept all legal responsibility for the roadway and all structures located in the designated area, and;

3. The Village of Avoca shall designate this section of roadway as “East Avenue Extension” and provide the proper street signage for the designated street and any and all structures located within the designated area, and;
4. The elected Board of Trustees has acknowledged that they have fully reviewed and taken into consideration all aspects of this proposed resolution, which has been voted on and passed by the elected Board of Trustees.

WHEREFORE, the Board of Trustees for the Village of Avoca hereby designate and fully authorized the above public thoroughfare to be the designated street of “East Avenue Extension” within the Village of Avoca.
