## **ENFORCEMENT POLICY**

STATE OF TEXAS COUNTY OF KENDALL

Pursuant to Section 209.0061, Texas Property Code, BOERNE SADDLEHORN HOMEMOWNERS ASSOCIATION, INC., sometimes "Saddlehorn HOA" or "Association" herein, acting through its Board of Directors, has adopted the following Legislation Act which was passed, Amending Section 1, Chapter 209 of the Property Code, to wit:

In accordance with the Declaration of Covenants, Conditions and Restrictions (CCRs) and Bylaws of said Association, each violation of any CCR and Bylaw Rules, as recorded, shall be considered on a case-by-case basis. If violator is not in compliance after a warning has been submitted, and a fine is to be imposed, as per the governing documents, it will be in the amount of and not exceed \$50.00 per violation, with the exception of free running dogs, which fine shall be imposed at \$100.00. Late fees of \$25.00 will be imposed for non-payment of dues as scheduled for payment in January of each calendar year. If not paid by March 1 of each calendar year, a lien will be filed against the property in arrears.
