This affidavit shall be entered into the record in any and all legal, administrative, or quasi-judicial proceedings now or in the future.

### I. AFFIANT'S STATUS

- 1. I, the undersigned, am a living man/woman, a divine creation of the Most High, sui juris, appearing in propria persona.
- 2. I am not a corporate entity, artificial person, trust, minor, ward, or subject of any administrative or foreign jurisdiction.
- 3. I do not consent to joinder with any legal fiction, including but not limited to the ALL CAPS name, trust accounts, or social contracts presumed by government actors or BAR members.
