1. while at or in proximity to this event to freely assume all risk of loss (including death) or damage or injury, collectively called "Loss" to myself, this dog or any dog under my control and to members of my family, my guests and to our property;
2. to release and discharge and to hold harmless and indemnify the organizing committee, the club and its directors, officers and members, the sanctioning body for the event (The Agility Association of Canada), sponsors of the event, and the owners of the premises or grounds upon which this event is held, and their respective employees and agents, collectively called the "Releasees" of and from any and all claims, and from all liability of any nature, for all Loss which I or this dog or any dog under my control or members of my family or my guests or our property may suffer for any reason or cause whatsoever, including specifically, but without limitation, all Loss resulting from the action or inaction of any dog, including this dog, or its owner or handler, or by the Releasees, or any of them, whether through negligence or otherwise. I expressly assume the risk and liability for all such Loss while attending or in proximity to this event and waive any and all claims relating thereto;

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and General Agreement/Disclaimer. I (we) agree to conduct myself (ourselves) in accordance with such Official Rules and Regulations (including all provisions applying to discipline) and to abide by any decisions made in accordance to them.
