treasurers report

I'm pleased to report that 2010 was a good year as we ended with a positive net gain. The slow market recovery helped to avoid any major losses in our investment portfolio during 2010. Despite the financial adversity in which we operate, Steere House remains committed to our strategic planning efforts which included the implementation of our Transitional Care Unit in 2010. As we look to the future. Steere House faces continued Medicaid rate reductions; however, the expansion of sub-acute, short term services will increase revenues while providing a continuum of care for the residents and patients of our surrounding local communities. Steere House is proud to be a leading provider of long term care services and will continue to use its resources in a prudent manner to remain a center of excellence for many years to come.

The total net operating revenue for Medicare, Medicaid, commercial insurers, and private pay clients was \$10,256,831 compared to operating expenses of \$11,624,993 for an operating loss of \$1,368,162. This compares to a 2009 operating loss of \$870,511. Net investment income gains of \$704,806 in 2010 (compared to a net gain of \$924,568 in 2009) contributed to a net gain of \$70,492 in 2010 compared to a net gain of \$709,283 in 2009.


