Association and the Fire District's Association of San Diego County establishes guidelines and a cooperative mechanism whereby the USFWS and the CDFW assess, minimize and help account for potential effects to sensitive species and habitats resulting from vegetation abatement activities necessary to reduce wildfire risk.

In January 2009, the City along with the USFWS, CDFW, County of San Diego and the San Elijo Lagoon Conservancy prepared the San Elijo Lagoon Vegetation Management Plan (http://www.ci.solana-beach.ca.us/vertical/Sites/%7B840804C2-F869-4904-9AE3-720581350CE7%7D/uploads/SAN ELIJO - VEG. MGMT PLAN.pdf) and signed a second more specific MOU for the purpose of establishing a vegetation management program for the lands in and adjacent to the lagoon. This program maximizes the protection of natural resources and minimizes the risk from wildfire in the City at the

wildland-urban interface along the San Elijo Lagoon. Fire hazard related policies are consolidated in Chapter 4 of the LUP.

The LUP requires the protection of native trees; including oak, manzanita, sycamore, cottonwood, willow, and toyon trees. Development must be sited and designed to avoid removal of trees and encroachment into the root zone of each tree. Where the removal

Mr. Tinkham,

Thank you for your response. We understand the importance of brush management near your community, but there is a process that was not adhered to.

The ESHA maps can be found on page 15 of this

Presently, the typical review process to seek approval for removing or impacting ESHA has involved a privately hired biologist with a prepared report proposing brush reduction, approval by the local office of the California Coastal Commission and the City, which includes review by planning and the fire department staff.

We will discuss this matter internally, and more guidance as to the next steps in the process will be provided as to the current clearing violation area and the proposed areas for brush reduction in your map. In the meantime, please make progress toward hiring a biologist. The areas recently cleared to the ground surface are beyond any standard of allowable brush reduction or thinning in an ESHA zone for defensible space purposes.

As a reminder, the presentations to the HOA's by the fire department informed attendees to coordinate brush reduction with the City prior to commencing the work. That did not happen in this instance.

Hi Daniel,





The City's LCP and LUP contain provisions restricting the removal of ESHA. City Council reviewed these policies in 2013: https://portal.laserfiche.com/Portal/DocView.aspx?id=9446302&repo=rc3b2ee98 Numerous opportunities for hearings and public comment were provided in this process. By adopted resolution, the City expressed agreement that it will administer project approvals covered by the LCP/LUP in a manner consistent with the California Coastal Act and in compliance with the Coastal Commission. The application for the clearing of ESHA may entail an application to the Coastal Commission, or it may be a local (City) application. We understand the need for your community to manage brush, and we intend to provide feedback as to how this process moves forward soon. In the meantime, please work toward retaining a biological consultant to assist the HOA with the habitat impact assessment necessary for brush reduction permits in ESHA zones.



- There must be a **documented procedure** by the City, to explain how to handle Fire Breaks. Please give me a copy.
- How can the City, tell an owner that he can't clear his property? Who is responsible, if a cleared area, could have saved their home. Also, this could force them to lose their insurance. And as you must know, insurance is a must for any mortgage company.
- As stated by you, there are areas that DON'T have habitat concerns or are excluded. Please note where.
- Homeowners are having their insurance cancelled or threatened, unless nearby vegetation is removed. Many are affected homeowners!! Insurance companies want a 100 ft cleared area from the home's roof.


- We/HOA understand that the Lagoon Managers/CA Park Dept does clear areas, but not necessarily on slopes, due to their equipment. We would like to coordinate with the Park Dept, to achieve a min 100 ft Fire Break along the Lagoon.
