I am confined in the state prison at CSP Paradise and was not first indicted by a grand jury. I have read "Newsom, we have a problem..." (incorporated herein by reference as published at withoutoneplea.com), which I believe to be a true and correct statement of the law; proving that the state of California has no authority to confine my person in the state prison unless I have been indicted by a grand jury.

Therefore, I hereby demand that you order the immediate and unconditional release of my person from the state prison. I declare under penalty of perjury under the laws of California that the foregoing is true and correct. Executed at Rocky Beach, California this 25th day of May, 2020.

Further, I understand that the California Victims Compensation Board provides a sum equivalent to \$140 per day of incarceration served for the pecuniary injury sustained by myself through the erroneous conviction and imprisonment.

NOTICE TO ABATE AND MITIGATE DAMAGES

In the event I am not unconditionally discharged from the state prison within 30 days of the date of this demand letter, you agree, by Executive Order or otherwise, to the increase of the above sum of \$140 to \$1,400 per day and, for each and every day of continued deprivation of my liberty, an additional and not less than, amount of \$2,000 per day.

NOTICE: Pursuant to Section 69, Subdivision (1)(b) of the Restatement of Contracts where silence or inaction operates as acceptance of the obligation to perform the act and to pay the amounts set forth above, I now give you every reason to believe and understand that assent by yourself as Governor of the state of California ("offeree"), may be manifested by silence or inaction and the offeree by remaining silent and inactive intends to accept the sum as set forth above and to make payment without objection in accordance therewith, for reason of the unlawful incarceration, prosecution, conviction, imprisonment and continuing illegal confinement of my person.

NOTICE TO THE AGENT IS NOTICE TO THE PRINCIPAL;
NOTICE TO THE PRINCIPAL IS NOTICE TO THE AGENT.

Therefore and otherwise, conduct yourself accordingly.

THE FOREGOING IS A SAMPLE LETTER FOR INMATE USE

Mandatory reading: "Newsom, we have a problem...". You are signing under penalty of perjury that you have read it, believe it and are relying upon it.

Recommendation: Re-type or hand-write the above letter as it appears...word for word; in order to effect the legal implications and contractual elements. Substitute inmate's personal information (name (Praying Prisoner), CDCR#, Housing, facility, address) and change the dates to date of mailing. Send as "Confidential Correspondence" on the envelope. Prepare an original and two copies (one for Ralph Diaz, Secretary (CDCR); one for your records) sign both pages and each copy, in blue ink above your name. Mail. Pray that God will move the hearts of the recipients to follow the law and act quickly.

Family, friends and those concerned: Download a copy of this "Sample" letter and "Newsom, we have a problem..." and mail to your incarcerated inmate. Follow up with your own letter (see "What Can We Do To Help?"). Also, pass the web page information (withoutoneplea.com) to others with friends in the California state prison system. Freely you have received, freely give. Let's all be home together for Christmas!
