

## WHAT CAN WE DO TO HELP?

### FAMILY OR FRIENDS OF INMATES WHO WANT THEM HOME

Write Governor Newsom a short demand letter; example:

Dear Governor:

My (Father, mother, uncle, brother, etc.) (name, CDCR #) is confined in the state prison at (CSP SOLANO, SAN QUENTIN, etc.) and was not indicted by a grand jury. I have read "Newsom, we have a problem..." and other articles and law at withoutoneplea.com which I believe to be true and correct and proves that the state of California has no authority to confine my (family member, friend) unless indicted by a grand jury. I demand you order (his/her) immediate and unconditional release from the state prison. And to the custody of none other.

### CITIZENS CONCERNED FOR JUSTICE

Reminder: The United States Constitution, California Constitution and California Penal Code all demand prosecution of an accused person by the State for Capital or otherwise Infamous crimes (punishable by confinement in the state prison) be commenced by manner of Indictment...no exceptions...there is no other way to get into state prison...period.

### ASKING THE QUESTIONS

Here are some ideas for questions to ask the Governor, Attorney General Xavier Becerra, your County Sheriff and District Attorney, Senator, News media (TV, RADIO, PAPER) etc..

1. Why are so many people in state prison who were accused of infamous crimes that were not indicted?

2. Why are so many people who were not accused of infamous crimes in the state prison?

3. Doesn't that make them illegally imprisoned, constituting injury?

4. What action is being taken to effectuate their release?

5. What action is being taken to provide compensation for their injuries?

6. Without the "Checks and Balances" of the Grand Jury isn't it more probable that overzealous prosecutors will convict and imprison those actually innocent of the crime for which they are charged?

7. What action is being taken to discontinue the unlawful imprisonment of citizens by "felony complaint"?

The use of a felony complaint by the state, being an unauthorized instrument and mode of prosecution, makes the complaint a false instrument and the filing of it in the court by the DA a felony. The state officers proceeding with the prosecution by complaint, at a minimum, is a violation of their oath of office, and a crime when offering a false instrument for record, offering a forged, or altered document in evidence as genuine, and preparing false documentary evidence. It became a conspiracy when the prosecution, judge and defense counsel agreed to proceed without objection to the bogus complaint and absence of indictment. This criminal conduct by public officers acting under color of law, deprived the accused of his Constitutional right to due process of law. This conduct violated at least California Penal Code Sections 115(a), 132, 134, 236 and federal law, 18 U.S.C. Section 241 and 242.

8. What action is being taken to hold accountable those persons responsible for these violations of the law?

After spending years without the companionship of your illegally incarcerated loved one, I'm sure you can think of a few more questions to ask the authorities...and demand an answer.

Google for addresses, e-mail and phone numbers. Don't give up until you have your loved one home and indictments are being sought by the DA for future serious and violent crimes. Send "Newsom, we have a problem..." or post on Facebook, Twitter, to all Senators, Representatives, Prison Reform advocates, etc.

Remember who you are...a member of the public, and the authorities are public servants. "A servant will not be corrected by mere words, for though he understands, he will not respond." Proverbs 29:19 (things haven't changed since Solomon's time!).

Keep asking, writing, calling until you see the Governor on TV and hear him say something like this: "I apologize to the people of this state for the illegal criminal prosecutions by the state's officers and unlawful confinement of persons in the state prison. Today I am ordering the immediate and unconditional release of all prisoners from the California state prison for whom no True Bill of indictment is of record."
