### Release and Waiver of Liability and Media Release Form

PLEASE READ CAREFULLY as this document affects your legal rights. This RELEASE AND WAIVER OF LIABILITY and MEDIA RELEASE FORM (the "Release") is executed by the undersigned in favor of ALL DOMESTIC, EXOTIC, WILD, ANIMALS LIVE MATTER RESCUE, and Illinois non-profit, its directors, officers, volunteers, and agents (collectively, "A.D.E.W Animals Lives Matter Rescue").

I understand that the behavior and temperament of all animals can be unpredictable and that touching, handling, or other contact with all animals may involve risk of property damage and personal injury. I also understand that if I bring a pet to the shelter, it may sustain injury or illness because of contact with all animals at the shelter. Therefore, as a condition of entering the shelter and/or interacting with all animals that are in the care of A.D.E.W Animals Lives Matter Rescue, I execute this Release subject to the following terms and conditions:

1. Waiver and Release. I hereby release and forever discharge and hold harmless A.D.E.W Animals Lives Matter Rescue and its successors and assigns from all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my visit to A.D.E.W Animals Lives Matter Rescue's shelter or interactions with all animals in the care of A.D.E.W Animals Lives Matter Rescue. I understand and acknowledge that this Release discharges A.D.E.W Animals Lives Matter Rescue from any liability or claim that I may have against A.D.E.W Animals Lives Matter Rescue with respect to any bodily injury, personal injury and illness, death, or property damage. I understand that A.D.E.W Animals Lives Matter Rescue does not provide any insurance coverage or financial assistance in the event of injury or illness. I acknowledge that I will release A.D.E.W Animals Lives Matter Rescue in any location where A.D.E.W Animals Lives Matter Rescue activities are conducted, of and from all claims which may hereafter develop or accrue to me on account of loss or damage, bodily injury, personal injury, illness, death or property damage, because of any matter, thing, or condition, negligence or default whatsoever, and I hereby assume and accept the full risk and danger of any hurt, injury, or damage which may occur through or by reason of any matter, thing or condition, negligence or default, or any person or persons whatsoever. Further, I understand that A.D.E.W Animals Lives Matter Rescue does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death, or damage to my property. I expressly waive any such claim for compensation or liability on the part of A.D.E.W Animals Lives Matter Rescue beyond what may be offered freely by A.D.E.W Animals Lives Matter Rescue in the event of such injury or medical expenses incurred by me. I hereby Prelease and forever discharge A.D.E.W Animals Lives Matter Rescue from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my visit to A.D.E.W Animals Lives Matter Rescue's shelter.

- 2. **Assumption of the Risk for Volunteers**. I understand that volunteer work/community service at A.D.E.W Animals Lives Matter Rescue's shelter may include activities that could be hazardous including, but not limited to working with all animals, cleaning, setting up and breaking down cages, loading and unloading equipment and materials, and transportation relative to work being performed.
- 3. **Photographs and Media**. I grant A.D.E.W Animals Lives Matter Rescue, as well as news and print media outlets, permission to use photographs of me with or without my name and for any lawful purpose, including for example, such purposes as publicity, illustration, advertising, web content, and social media.
