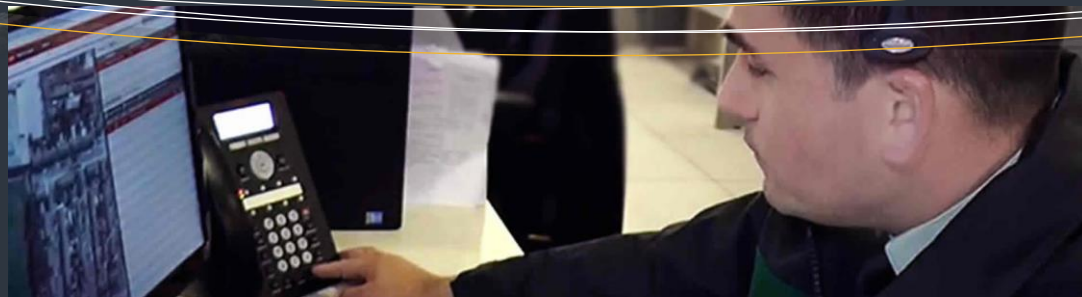

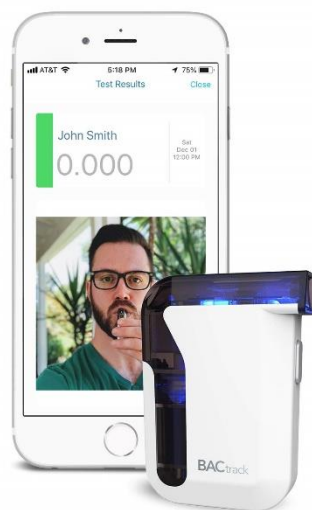
At only 1.75 oz., **BACtrack** can be easily carried in a pocket or purse to enable the participant to maintain compliance.

The first pocket size handheld video digital breathalyzer to securely monitor breath alcohol. The device takes a video of the user during the breath test to positively verify identity.

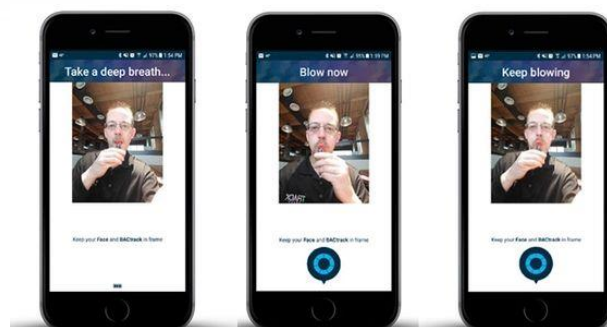
## Master video is taken during enrollment.

Using a breathalyzer for your alcohol monitoring tests is less intrusive than an ankle monitor.

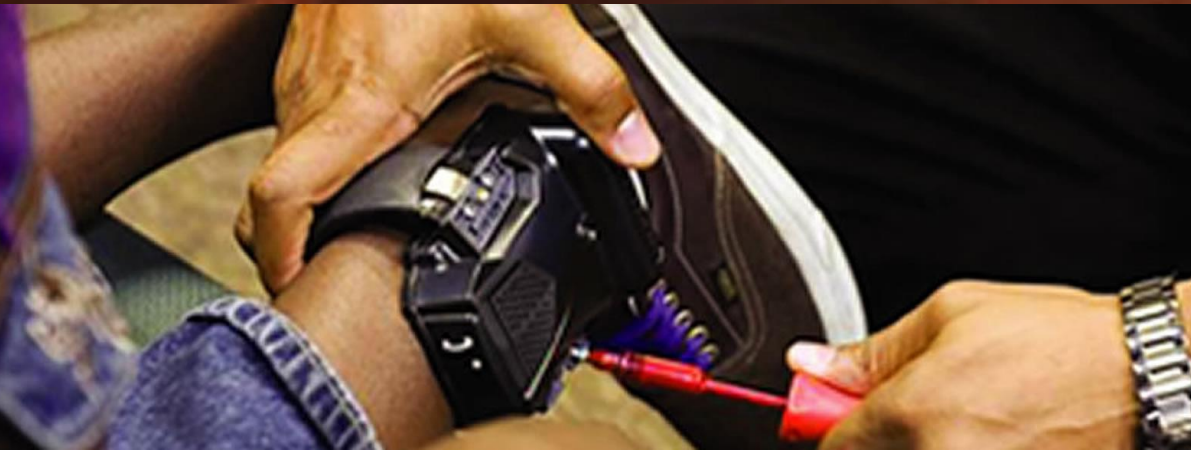
The first pocket size handheld Video enabled breathalyzer to securely monitor breath alcohol.

The SecureCuff has a laminated fiber optic tamper alarm cable between two hardened stainless steel bands.

If an offender cuts through the first stainless steel band, the fiber optic cable triggers an alarm.

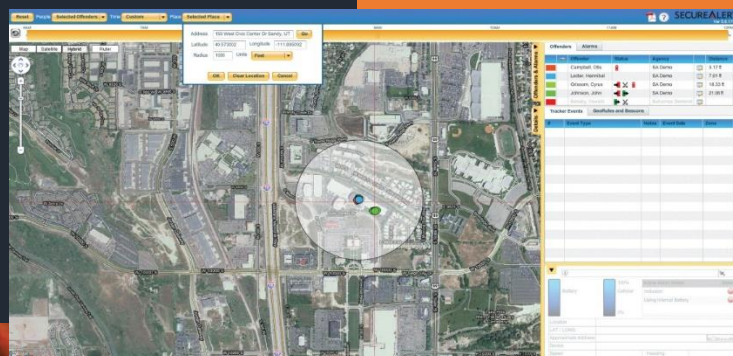
The offender still needs more time to cut through the second band, giving officers to time to successfully respond to and prevent a potential "cut and run"

### Added Security

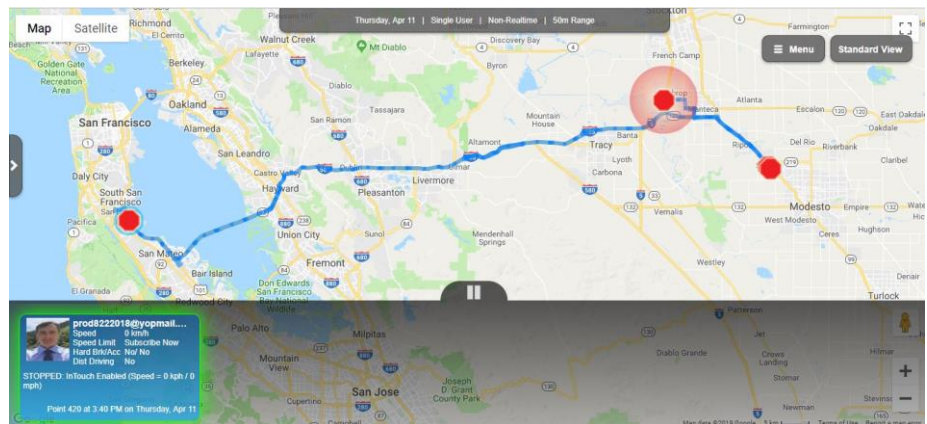

## Facial Recognition

InTouch – A smartphone monitoring and supervision application that was specifically designed for the Criminal Justice market to compliment traditional Electronic Monitoring solutions.

Development came from customer demand for a monitoring solution for “low to high risk” participants that do not require traditional ankle monitors.

## How it works

Clients are issued login credentials. They download our app and log in.

We then request a “Test Now” to start the enrollment process as well as the facial recognition.

Clients will have to check in randomly via their phone app. While checking in, the software takes a photo and logs their location.

This ensures it is the right person checking in and it verifies compliance or violations.

### 1 First Contact

### 2 Turned down by the Jail, Probation, or the Sheriff's Department

# Private Monitoring Solutions

**We provide services to both the accuser and the accused**

## The Victim

GPS Monitoring is the self-help solution to those in need of protection. The person restrained is outfitted (tethered) with a monitoring device. In the event the restrained person violates the court-ordered distance, the protected person is immediately notified of the violation or eminent by a phone call. In essence, this unique system provides a "virtual Safety Zone". Sometimes all that's needed is a head start. Better for law enforcement to write a report for a restraining order violation, than a lengthy investigation after (an unimaginable and potentially avoidable event) deadly crime.

## Victim Notification

Introducing a smartphone application that creates a mobile geo-zone around a victim and works in conjunction with the offenders tracking device providing a reliable early warning notification to the victim when they are in close proximity to the offender. Likewise the person wearing the device is notified/warned that he/she entered into a restricted zone.

## The Accused

On occasion, an estranged, spouse or partner will ask for and receive a restraining order from the Court. The order may include a GPS device. However, when wrongly accused, the restrained person can opt to equip themselves with a GPS tracking device which factors the accuser's home and employment stay-away zones. During a hearing for contempt, or; to make the order permanent, GPS data provides the Court accurate information to assist in determining an impartial decision. If you are being monitored with one of our devices, we can prepare a report for the court and your attorney with complete location details. Why be at the mercy of the court, fighting false allegations without proof?

The device is the most tamper proof in the industry and even if your smart teenager tries to take it off in some fashion, you will be alerted immediately!

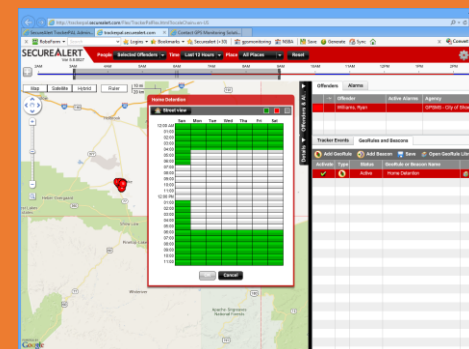
**Know where your child is at all times.** Feel more comfortable letting them leave with their friends. With the click of a mouse, you will always know where they are.

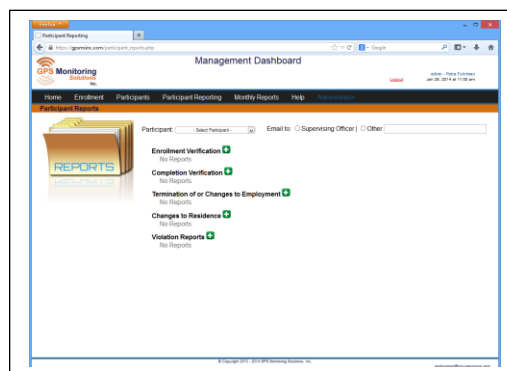
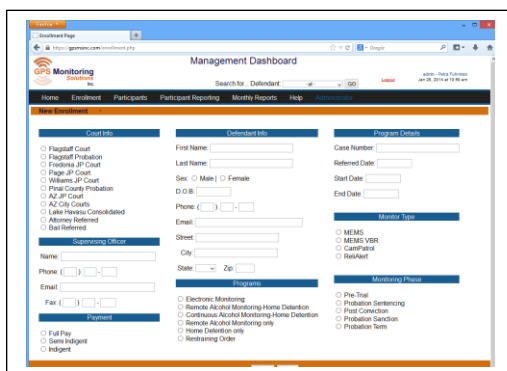
The screenshot below illustrates current location of a participant and his curfew schedule for home detention.



## Reporting:

We developed an offender management software/database.

It captures all enrollees, start date, completion date, violations, change of residence, change of employment, successfully completion of program, participants currently in program etc.

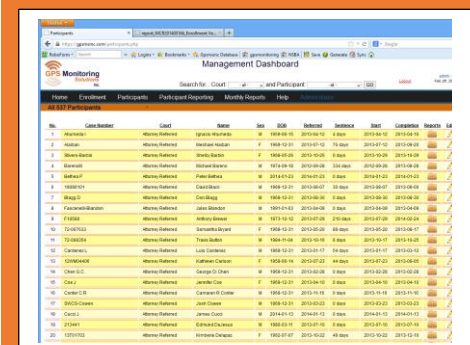


Should the participant have an unauthorized absence of his/her curfew/Home detention and or work schedule, we are notified by the monitoring center immediately. In addition, we are able to expeditiously notify the court of late returns, equipment malfunctions, tampering and other events. This data is stored directly within the monitoring center and retrievable at any time.

Reports will be issued for:

1. Enrollment
2. Completion
3. Violations
4. Progress Reports

Weekly and or monthly reports are available per request of the court.

## Enrollment Process:

Upon sentencing by the court, defendants are issued an enrollment form which states when installation needs to occur.

1. Defendant schedules an appointment with the staff of GPSMS for enrollment.
2. GPS Monitoring Solutions Inc. will install device at location requested by the court.
3. GPS Monitoring Solutions Inc. staff will verify identity by picture identification, government identification, driver's license, or passport; with corresponding minute order; address, and employment.
4. Defendant will sign lease agreement with GPS Monitoring Solutions Inc. and pay for initial set up and monitoring fees. Monitoring fees may be paid via payment plan to fit participant's budget.
5. Staff enters all client information into monitoring center
6. Staff enters all court ordered restrictions such as home detention
7. Defendant is equipped with alcohol and or gps monitoring device
8. Staff send enrollment letter via fax/email to the court
9. Staff will fax completion and or violation letters to the court on the same day of occurrence
10. Corporate office of GPS Monitoring Solutions Inc. will submit weekly and or monthly reports to the court with requested details, including enrollees, completions, violations, etc.
