# President, Ann Parks

Harley and I have transitioned to our northern home like many in our association. However, that doesn't mean the life of an HOA President is all family and fun for the summer. I wish!

Rest assured the Board and I are still on the job, handling issues that arise on your behalf.

To that end, please be aware, that if you are selling a home, prospective buyers must pass a background check and participate in a personal interview PRIOR to receiving clearance by the HOA for the home sale prior to the closing. These two items are required by our governing documents (Declarations). The information on competing these items is clearly stated on the association website on the new resident page. The HOA holds the Estopple form required by the title company until these items are completed. As the seller, you can ensure this process goes smoothly by making sure the realtor and title company both know about the process, and the website.

The required application is emailed directly to me at <a href="mailto:parksa8@yahoo.com">parksa8@yahoo.com</a> and the required fee for the background check (\$100 per couple or \$80 per individual) may be paid by check or conveniently by credit card on our secured website (halfway down the main webpage where it says online payments). Once the background check is completed, the prospective purchaser will be contacted to complete the personal interview by Dot Dodge Hospitality Director, or another Board member if she is unavailable.

The other item I need members to be aware of is that there is a current moratorium on all exterior building projects. The Executive Committee met with the Building Committee on April 8th. There is a need for revision to the Governing Documents (Declarations) in several areas primarily due to changes in the state statutes covering HOAs. Our governing docs need to be brought into compliance. If members have an emergency and simply can not wait until the new year for the rules process to complete, we would ask that you complete a building request and submit it directly to Vice President Larry Way, who is responsible for working with compliance on all our committees. He will meet with the Building Committee members present to process your request.

#### 2024 Federal Taxes

Tax information is currently at the HOA's accounts Murtha & Flischel CPA in Zephyrhills. They review our Quicken file and prepare our federal tax return. As a Florida non-profit we do not traditionally pay federal income taxes as we do not make profits or keep large reserves of cash (accounts). As we change our business practices in response to new state requirements, I will be interested to see what if any affect it has on our tax profile.

As of our last update from the accountant, an extension has been filed for our taxes and the return shall be finalized and filed in May when our accountant returns in mid to end of May.

#### **Annual Dues**

Thank you to all who have sent in their 2025 HOA Annual Dues, either if full or a first payment on a payment plan. To date, out of 147 homes, 121 have paid their 2025 Annual Dues in Full. A further 24

residents are paying their Annual Dues on one of the payment plans; 10 semi-annual, 9 quarterly and 5 on monthly plans. I am only missing payments from two (2) residents: two are not in residence and are putting their homes up for sale or will be here shortly to decide; leaving one of resident I have not been able to contact at all directly by phone or email and have sent registered letter to their next of kin as listed in park records.

With the state required changes to the website, the financial reports, board and member meeting minutes, and most other association documents are now filed each month in the new secured MEMBERS ONLY section of the website. If you want to access this area you need to request access. Simply go to our website at <a href="https://www.oaksroyal3.com">https://www.oaksroyal3.com</a> or click on the button below and click on the HOA Member Only link at the top of the page (in may be under More in your browser) and then choose "Create Account". After you complete that information, I will approve your request and you will receive a link to create your password and get access.

The other new feature is on the main page of the website under "Online Payments", about halfway down the page. There is a new secured section where you will be able to make you annual dues payment by credit card if you so choose. This is possible as we have had to upgrade our website to a secure (https) server, the web server GoDaddy uses the same encryption used by banks and businesses to secure your web-based transactions. There is a button below to go directly to the secure online bill pay page.

#### Isle of Eight Flags Shrimp Festival, May 2-4, 2025

This will be the 60th annual shrimp festival in one of Florida's most productive shrimp regions. Pirate Parade, exhibits, arts and crafts, antiques, games, contests, seafood and live music along the Amelia River in downtown Fernandina Beach.

#### Fort Lauderdale Air Show, May 3-4, 2025

Beachfront air show, scaled down from its heyday. To kayak nearby and avoid traffic: Florida Rambler story on the Fort Lauderdale Air Show.

#### Tupelo Honey Festival, May 17, 2025, Wewahitchka

Where is Wewahitchka and what exactly is Tupelo honey (other than a Van Morrison song)? Wewahitchka is in the Big Bend region of Florida near Tallahassee. Tupelo honey is a seasonal delicacy because Tupelo trees only bloom from April to May and top-quality honey comes from only the trees in the Apalachicola River valley. It is so special that you won't find it in stores. At this festival, farmers from the area offer honey in a variety of sizes and packages under the moss-draped oaks around Lake Alice. The small-town festival also offers food vendors, art and crafts, live music and, of course, there is a Miss Tupelo Honey queen.
