FAMILIES. WE SUPPORTED LOW-INCOME FAMILIES' EFFORTS TOWARD SELF-SUFFICIENCY
BY PROVIDING THEM WITH \$241,534 IN CHILDCARE SCHOLARSHIPS AND \$170,075
CHILDCARE ASSISTANCE TO 33 EMPLOYEE CHILDREN. IN ADDITION TO ENABLING
