Policy Agreement

The Cinco De Mayo Music Fiesta Committee shall have the right in its sole discretion to disapprove of any items offered or displayed, and the method the item is displayed. Disapproved items shall be removed by the vendor at the request of a member of the Committee. The Committee's interpretation of all rules is final and binding on any vendor. All vendors shall be in keeping with the overall family-oriented theme of the fiesta and is subject to the approval of the committee.

- Vendors will participate at their own risk and expense.
- The Cinco De Mayo Music Fiesta assumes no responsibility or liability for any personal injury loss or damage.
- A signed Policy Agreement and Application serves as a commitment to be present at the Cinco De Mayo Music Fiesta on May 3, 2024, and/or May 4, 2024.
- Security will be on the premises from the time the doors open until the doors close each night.
- The Cinco De Mayo Music Fiesta will not be responsible for refunding fees for any reasons, including inclement weather.
- A \$25.00 fee will be charged on any check returned by the vendor's bank.
- Sales tax collection is the vendors' sole responsibility.
- Parking and traffic will not be permitted in the fiesta area or around the buildings two hours prior to doors opening. Vendors will be allowed to load/unload items in a timely manner and promptly then move vehicle.
- Tables, table covers, chairs, extension cord, etc. will be the sole responsibility of the vendor.
- Vendors must supply their own plates, napkins, cups, utensils, etc.
- All vendors will be responsible for cleaning their designated area during and after the conclusion of the fiesta.
- Each vendor will receive 5 wrist band passes. All extra personnel will be required to pay admission fees.
- **NO OUTSIDE ALCOHOLIC PRODUCTS WILL BE PERMITTED ANYWHERE WITHIN THE FIESTA PREMISES.** Failure to adhere to this instruction will warrant being evicted from the fiesta, without a refund of paid fees, by the committee chairperson and security.
