

Terms & Conditions

These terms and conditions ('Terms') govern the users ('you' or 'your') use of the website www.ThatHappyCompany.com ('Website') and your relationship with That Happy Company. Please read the Terms carefully as they affect your rights and liabilities. If you do not agree to these Terms, you are not permitted to access or use the Website. Minors or people below 19 years old are not allowed to use this Website. If you have any questions or concerns regarding these Terms then please contact us.

1. Agreement:

By using the Website you agree to be bound by these Terms.

2. Amendments:

We reserve the right to update these Terms from time to time and any changes will be notified to you via a suitable announcement on the Website. It is your responsibility to check for such changes. The changes will apply to the use of the Website after we have given such announcement. If you do not wish to accept the new Terms you should not continue to use the Website. The legal personal carry limit of legalized recreational cannabis is 30 grams per person. We reserve the right to cancel orders and/or suspend accounts where we believe products are being ordered in breach of this provision and/or any AGCO Guidelines or cannabis laws.

You will assume the risk for the products once they have been dispatched out to the delivery address which you specified when ordering the products. We accept no liability where you provide an incorrect delivery address or where you fail to collect the products from the delivery address which you specified.

10. Same Day Delivery Service:

We are currently offering FREE SAME DAY CANNABIS DELIVERY* to private residential addressed in select municipalities across the province of Ontario including Vaughan, Richmond Hill, Thornhill, Markham, Unionville, Pickering, Ajax, Whitby, Brooklin, and Oshawa.

Delivery hours are from 2pm to 8pm. To ensure delivery on the same day, please make sure to place your order online before 12:00pm Eastern Time. Orders received after 12:00pm Eastern Time may be delivered on the next business day or, in the event of black out delivery days or holidays, the next delivery day.



FREE SAME DAY DELIVERY* is available only on orders over \$65 (before taxes and fees). Orders \$64.99 (before taxes & fees) or less are subject to a \$12.00 Delivery & Handling Fee. Delivery & Handling Fees are non-refundable. No exceptions.

During the checkout process, please ensure that you provide your full name, phone number, email, and full delivery address at checkout. Once we receive your order, we will contact you with an ETA and the next steps.

Due to the very strict cannabis delivery guidelines, you are required to meet the driver at the front door. You must have the payment card used for purchase and matching valid government-issued photo ID ready to show the driver. Acceptable forms of photo ID are an Ontario Driver's License, Ontario Purple ID Card, or Canadian Passport. Ontario Health Cards are not accepted.

11. Refund Policy:

Please note that all products are very carefully inspected for quality, assortment, and proper packaging prior to shipment. However, manufacturers may screw up, shipping carriers can err, and yes, even we might make a mistake from time to time. Nobody is perfect, and we know that. It is important that you check your order or items upon receipt and always before use.

All sales are final. No exchanges. No refunds. No returns. No exceptions. Our Refund Policy is part of, and should be read in conjunction with, our Terms and Conditions. Policy details are subject to change without notice.

12. Price and Payment:

All prices shown on the Website are in Canadian Dollars and are subject to Ontario Harmonized Sales Tax (HST). Prices are correct at the time they are entered on to the system. We reserve the right, however, to change prices at any time without notice.

Payment can be made by any major credit card or debit card. Full payment will be debited and cleared from your account before the dispatch of your order. In the unlikely event that the price shown on the checkout page is wrong, and we discover this before accepting your order in accordance with clause 9, we are not required to
