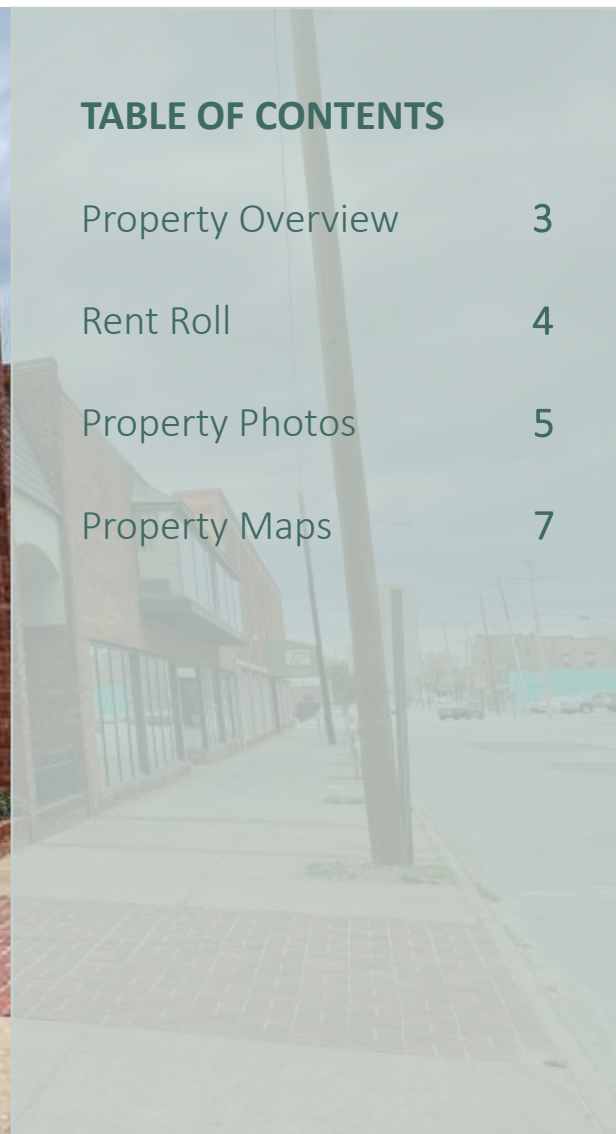

The building was constructed in 1955, with a **NEW ROOF** installed in July 2021, and is two-level, consisting of flexible office spaces, warehouse area, and shared amenities including conference rooms, break rooms, coffee bars, lounges, and video conferencing software.

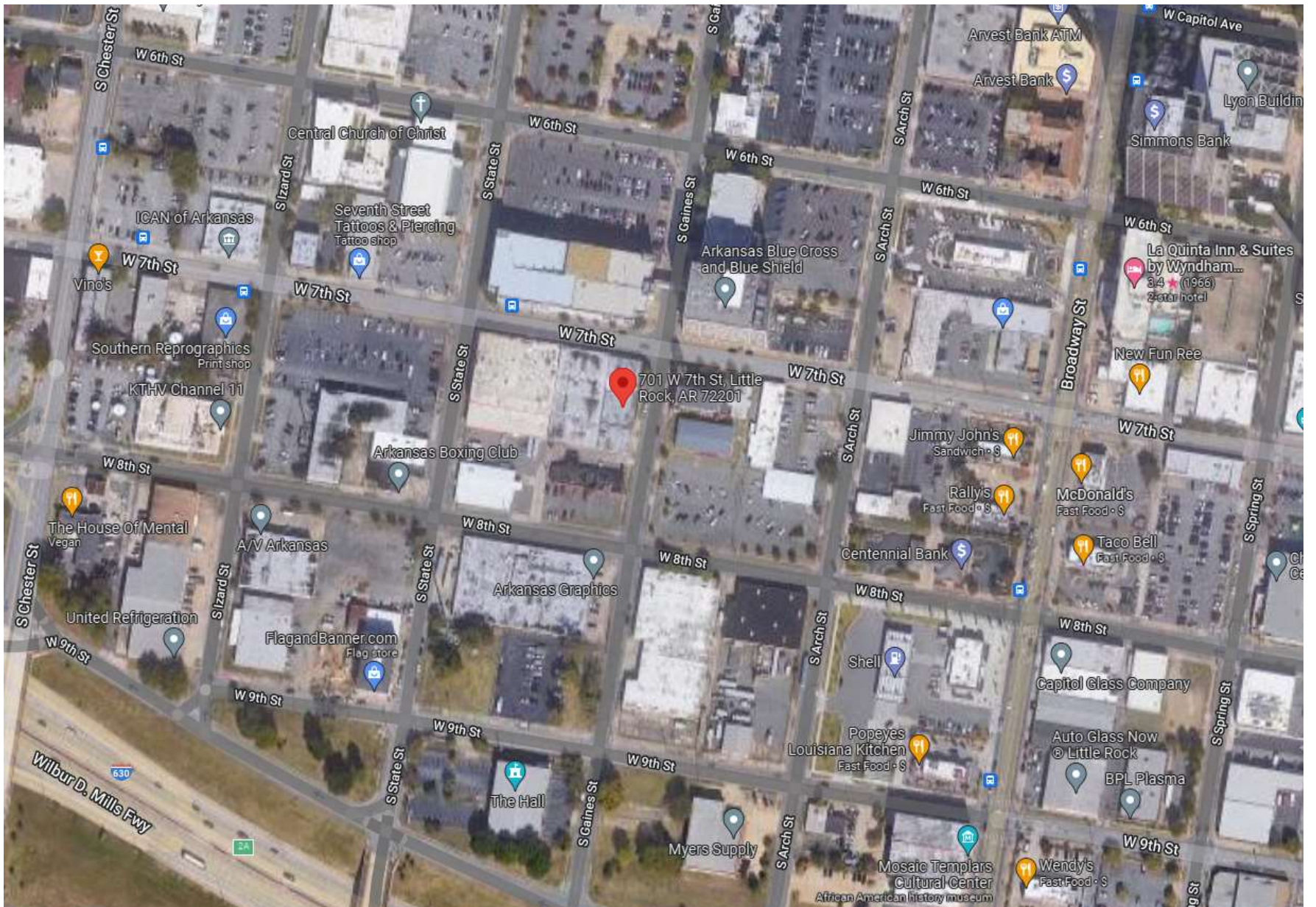
