Dear Parents and Legal Guardians, we really look forward to having your family as our guests at the Party ("Event") on October 19th, 2024!

Jason and Joanna Landrum ("Event Hosts") want the evening to be enjoyable and safe for all involved. If Parents/Legal Guardians ("You") truly cannot attend with your child/ward, a completed Event Waiver will be required for your child/ward to attend.

### **MINORS WILL NOT BE SUPERVISED DURING THE EVENT.**

**Parent/Legal Guardian signature on this form affirms that You have read and fully understood that Event Hosts, or their agents, representatives, affiliates, contractors, employees, or vendors cannot be held liable should your child not adhere to what is outlined and agreed to here, or should they engage in other inappropriate behavior that may cause harm to them or to others.**

**We ask that you kindly send us your child/ward's completed Waiver if you will not attend, when accepting the invitation today, or by Saturday, October 5th.** Please read this Event Waiver in its entirety and contact us if you have any questions: 954-593-5615. ### **MINORS WITH LICENSES TO DRIVE**

If your child/ward has a valid license to drive and You allow him/her/them to transport themselves to the Event, this additional information is important to note:

If You allow your minor to transport themselves, or to be transported by another minor: You understand and agree to the conditions found in the ASSUMPTION OF RISK AND LIABILITY DISCLAIMER: EVENT PARKING LOT, (found at [www.LandrumHalloween.com](http://www.LandrumHalloween.com)) in their entirety, to fully understanding them, and agreeing to be bound by them.

If You allow your child/ward to transport themselves to and from the Event, or if You allow your child/ward to be transported by another minor to and from the Event, You:

- a. Understand and agree that NO adult supervision is provided while at the at the Event.
- b. Keeping Tennessee Curfew laws in mind, You and your child/ward agree to a time they should leave the event to be compliant with these laws.

c. Understand and agree that the Event Hosts, their affiliates, representatives, agents, contractors, vendors, or employees are not responsible for supervising your unaccompanied minor, or to ensure that he/she/they returns home/ or to your agreed upon destination on time.

### **ALCOHOL ON THE PREMISES**

You understand and agree that this is a private event in a home that hosts guests from various age groups; alcohol will be present; your child/ward is expected to ONLY consume the non-alcoholic beverages served to them by licensed bartenders at the Event.

### **AGE-RESTRICTED AND ILLEGAL SUBSTANCES AND WEAPONS**

You and your child/ward understand and agree that he/she/they is not permitted to bring to the Event any form of illegal or age-restricted or controlled substances such as alcohol, prescription medication not prescribed for them, illegal narcotics, vapes, Juuls, cigarettes, e-cigarettes, cigars, including any other forms of illegal or age-restricted substances not listed here, or weapons such as guns, knives, sharp objects or objects with blades, or any objects that may be deemed to be potentially dangerous or harmful to Self and to others.

Anyone found to be in possession of substances and objects such as those listed here will be isolated and parents will be contacted to return their child/ward home immediately.

### **COVID-19 WAIVER/DISCLOSURE STATEMENT AND POLICY**

By accepting an invitation to this event, You are acknowledging that an inherent risk of exposure to COVID-19 still exists in any setting where people are gathered. By attending this event, You voluntarily assume all risks related to exposure to COVID-19 and agree not to hold the Event Hosts, or any of their affiliates, representatives, agents, contractors, vendors, or employees liable for any illness or injury.

If You or your child/ward develop symptoms of the COVID-19 virus (fever, cough, etc.,) or learn you/your child/ward may have been in contact with a COVID-19 positive person after accepting an invitation, please do not allow them to attend the Event. We must all endeavor to keep ourselves and others safe.

### **EMERGENCIES**

It is imperative that You provide the best phone number(s) on this Event Waiver so that You can be reached should a situation arise during the Event where Event Hosts, or their agents, representatives, affiliates, contractors, employees, or vendors notice that emergency intervention is indicated for the underage guest listed below. Every attempt will be made to notify You. By signing below, You grant your express permission to allow action to be taken on your child/ward's behalf, whether or not You can be reached.

If it is felt that emergency medical attention and treatment is required, your signature below indicates that You allow your child/ward to be transferred to the nearest emergency facility for treatment and that You accept full financial responsibility for any and all attention and treatment provided.

#### **UNACCOMPANIED MINORS: CURFEWS AND UNDERAGED DRIVERS**

You and your child/ward understand and agree that it is your and your minor's responsibility to ensure that he/she/they adheres to all applicable State Laws regarding Curfew. The only exceptions to the operation of the Curfew are if the minor is accompanied by his/her/their parent or legal guardian or when accompanied by an adult authorized by a parent or legal guardian of the minor to take the parent or guardian's place in accompanying the minor for a designated period of time and purpose within a specific area. Authorization of such person will not be verified by Event Hosts, or their agents, representatives, affiliates, contractors, employees, or vendors.

You understand and agree that there will be NO supervision provided at the Event to ensure that your minor departs the event on time as is applicable to TN State Curfew laws, or with the driver You expect, or to the destination You expect. NO supervision is provided in the Parking Areas.
