- 3. The estimate/original price for work includes all labour. Green waste disposal if required must be agreed separately.
- 4. Any addition and/or alterations to the contract shall be properly treated as variations and subject to written instructions and additional payments may be required to cover the agreed changes.
- 5. The client shall provide water and electricity, if needed, at no charge to Mary Mary Creates Gardens Ltd. The client shall provide access to site and dry storage space for materials when appropriate during the works progress and during Mary Mary Creates Gardens Ltd working hours. Our working hours are typically 8:30am-4:30pm, however specific hours and times will be agreed before commencement of works.
