

# Twinflower Books' FISH STORIES writing contest

### Eligibility

Anyone residing or working in Chisago County, MN may enter this writing competition.

Individuals must be aged 13+ for the Poetry, Nonfiction, and Fiction categories.

Individuals must be in grades 4, 5, or 6 for the 2023-24 school year for the Young Storyteller category.

## **Categories**

Four categories are offered for 2024:

- Poetry, ages 13+
- Nonfiction, ages 13+
- Fiction, ages 13+
- Young Storyteller, grades 4, 5, or 6

## Requirements

The fish story must be original.

The fish story may be a poem, fiction, or nonfiction.

Students entering the Young Storyteller category may write a poem, fiction, or nonfiction and should indicate this at the top of their submission.

The fish story must be text only – no images may be used in the story. If images are submitted with the submission they will be removed before judging begins.

## Length:

- Poems: no more than 200 words
- Nonfiction and Fiction: no more than 1,000 words

The fish story may not contain: 1) slanderous language; 2) defamation (of a person, product, brand, location, or region); 3) commercialized information about a product or company; 4) plagiarized material or content.

No purchase or donation is required to submit for this contest.

## **Judging Criteria**

Two judges will review each submission against the scoring criteria. The scores from the two judges will be added to provide an overall score (maximum score points = 43). In the instance of a tie for the prize, a third judge will be asked to be a tie-breaker.
