

## Meet Willie Robertson Fundraiser Contest Official Rules and Guidelines

## <u>Rules:</u>

- Set up a Fundraiser for Safe Haven Baby Boxes during the contest period. For instructions on how to set up a fundraiser, visit our website <u>https://shbb.org/resources</u> and scroll to the bottom of the page to download instructions document.
- Notify Safe Haven Baby Boxes by sending a Facebook message or email to <u>shbb@safehavenbabyboxes.com</u> to let them know your full name and the date you started your fundraiser.
- 3) Fundraiser starts at 12:01AM EST on January 1, 2020 or later and ends at 11:59PM EST on January 31, 2020.

## Prizes:

FIRST PRIZE: The person with the highest\* raised funds will be awarded two VIP tickets to the Safe Haven Baby Boxes 2020 Gala, expenses paid for travel\*\* and one (1) night hotel stay.

## OTHER PRIZES:

Contestants who raise:

- \$500 or more\*\*\* will be awarded one (1) VIP ticket to the Safe Haven Baby Boxes 2020 Gala.
- \$250-\$499\*\*\* will be awarded two (2) regular admission tickets to the Safe Haven Baby Boxes 2020 Gala.
- \$150-\$249\*\*\* will be awarded one (1) regular admission ticket to the Safe Haven Baby Boxes 2020 Gala.

\*In the event of a tie with the highest funds raised, donation period will be extended an additional seven (7) days, ending at 11:59PM EST on February 7, 2020. A drawing on or after February 8, 2020 will take place if a tie in the highest funds raised still exists.

**\*\*Travel includes** two (2) coach class airfare tickets, one (1) overnight stay at a local hotel of SHBB choice, two VIP reception tickets, and two tickets for Gala event. SHBB will not be responsible for any other costs associated with travel or at the event. Prize does not include purchase of alcoholic beverages at the event. If winner lives less than 100 miles from the Grand Wayne Convention Center or if winner chooses to drive instead of fly, winner will be given a check in the amount of \$100 for transportation expenses to and from Gala event.

Safe Haven Baby Boxes, Inc. shall have no liability for Winner's failure to receive notices due to spam, junk email or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. Winner cannot be contacted, is ineligible, fails to claim the prize within thirty (30) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. In such case, Safe Haven Baby Boxes, Inc may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Safe Haven Baby Boxes, Inc. Safe Haven Baby Boxes, Inc. reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or violates these Terms & Conditions.
