HMRC is changing the law. The once-a-year tax return is being phased out, and the "Digital Revolution" is here. You can ignore it, or you can *get ready*.

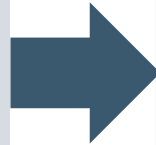

When Does Making Tax Digital Start?

MTD is being introduced in stages:

- April 2026 - Mandatory if income over £50,000
- April 2027 - Mandatory if income over £30,000
- April 2028 - Mandatory if income over £20,000

If you're self-employed or earn rental income, you are likely to be affected.

The New Penalty System

HMRC is introducing a points-based penalty system.

Miss submissions or fail to keep digital records and penalties build automatically.



Possible consequences:

- Late submission penalty points
- Financial penalties
- Compliance investigations
- Fines of up to £3,000+ per year
