#### Minutes of the THMGC Executive Board Meeting on Monday, 10 February 2025

The following are the minutes of the Temeku Hills Men's Golf Club Executive Board meeting on Monday, 10 February, 2025.

The President Scott Mayfield called the meeting to order at 2:00pm. The members in attendance were Ron Frederick, Bob Dubay, Sean Dillon, Lee Wortman, John Hannaman and Jim Loy. The agenda for the meeting is attached as Enclosure #1.

A motion was made and seconded to approve the January Minutes and passed unanimously by voice vote.

The Treasurer Ron Frederick submitted the Proposed Budget for 2025, and the January 2025 Financial Report (Enclosure 2 & 3)

The Board reviewed the 2025 Budget as Ron Fredrick talked everyone through it. Memberships to date account for \$8,000 in income. The anticipated expenses total to \$7,150. The board acknowledged that the expected income for the year would be down due to the number of members opting to play at other courses. The full impact will not be known until we progress through the year.

The THMGC began the month of January with a cash balance of \$6896.17. The income and expenses are itemized in the attached January Summary. The income for the month: Memberships \$1552, and 2025 Yearbook Ad Sales \$125. The expenses are itemized on the Summary (Encl 3). The closing bank balance for Jan 2025 was \$8044.84. Comparing this year's balance to the same time last year shows a -\$192 in the budget.

The Board discussed the option of spending some of the balance on the members in the form of lunches after each of the Major Tournaments. It was decided to fund lunch after the Legends Cup. Further additional lunches would be approved so long as the membership income did not further decrease significantly.

A motion to approve the financial report was made and seconded. It was approved unanimously by voice vote.

Tournament Chair Bob Dubay explained the upcoming Tournament for February would be the first Major of the year – The Legends Cup (Feb 19<sup>th</sup>) The plan is to use all four Tees, but final decision will be dictated by the number of members who sign up for play.

Web Chairman Sean Dillon has graciously agreed to fill in as Web Chairman in the absence of Knute Jackson who has resigned.

- Course condition and its impact on membership and weekly play were discussed. Many of the members who have departed due to course conditions indicated that they would return if the course begins to show improvement.

#### **New Business**

- The General Membership Meeting will be held on February 19<sup>th</sup> prior to the Legends Cup Tournament.
- Board Membership has been impacted by resignations. There is currently an opening for Vice President and Web Chairman. An effort will be made at the General Meeting to recruit volunteers to fill these vacancies and help maintain the vitality of the Board.

**Adjournment** A motion was made and seconded to adjourn the meeting. It was carried by a voice vote and the meeting adjourned at 1:58pm.
