A motion was made and seconded to approve the December Minutes and passed unanimously by voice vote.

The Treasurer Ron Frederick submitted the budget summary for Dec / Brunch Summary / Annual Review. (Enclosure 2, 3, 4)

The THMGC began the month of with a cash balance of \$10,550.08. The income and expenses are itemized in the attached December Summary. The income for the month: Memberships \$886, Christmas Brunch Tickets \$925, 2025 Yearbook Ad Sales \$50. The expenses are itemized on the Summary (Encl 2). The closing bank balance for Dec 2024 was \$6,896.17. Comparing this year's balance to the same time last year shows a -\$699 in the budget.

The Christmas Brunch Financial Summary is at Encl 3.

The monthly annual summary breakout is at Encl 4.

A motion to approve the financial report was made and seconded. It was approved unanimously by voice vote.

Tournament Chair Bob Dubay explained the upcoming Tournament for January would be the Modified 4-Ball with 2 Man Teams on January 22nd.

Membership Chair John Hannaman reported the membership numbers for the prior month and the current month:

Handicap Chairman Sean Dillon said that there were a routine group of 5-6 who failed to post their scores. He intends to speak with them individually.

Web Chairman Knute Jackson had no update to the Web operation.

Rules Chairman Lee Wortman told the board that he had rewritten the "Out of Bounds" rules for Holes #5 and #18. This will be added to the Yearbook.

Old Business ---

- Scott Mayfield reminded everyone of the plan for a 4th of July Barbeque. A number of options
 were considered and the issues associated with each discussed. Everyone agreed that planning
 needed to commence immediately, so that any obstacles identified could be overcome.
- 2. A significant amount of time was spent discussing the condition of the Course and what, if anything could be done by the Men's Club to impact it in a positive way. It was noted that approximately 15-18 "daily members" had elected not to renew their memberships and sign short term contracts with other courses some joining the Men's Club at that course. All agreed that we would have to wait until the first quarter finished to see if any of those electing to depart might return.
