

Minutes of the THMGC General Membership Meeting on Wednesday, 14 August 2024

The following are the minutes of the Temeku Hills Men's Golf Club General Membership meeting prior to play on Wednesday, 14 August 2024.

The President Pete Johnson called the meeting to order at 7:45 AM. There were 48 members in attendance.

The Treasurer Ron Frederick submitted the budget summary for July. (Enclosure 1)

The THMGC began the month of Jun with a cash balance of \$5,907.60, plus a CD worth \$3,000. The income and expenses are itemized in the attached Financial Report. The closing balance for July 2024 was \$6,467.60. Comparing this year's balance to the same time last year shows a -\$223 in the budget.

Ron Frederick reminded the members that plans for expenditures included lunch after the second day of tournament play and the Christmas Brunch subsidy.

A motion to approve the financial report was made and seconded. It was approved unanimously by voice vote.

Tournament Chair Bob Dubay reminded the group that at the end of tournament play on the 21st, the Men's Club would be paying for lunch in the Grill Room after play. Beverages would be the responsibility of the member.

Bob reminded all to keep a second scorecard during the tournament to avoid errors in scoring.

Bob explained that the Club would be utilizing Golf Genius over the next few weeks in a test mode to familiarize members with how it works and to confirm its capabilities for those setting up the tournaments.

Bob reminded all members of the modified course rules regarding Lift-Clean-Place, with only the greenside bunker on hole #10 being a drop outside to the nearest edge.

Handicap Chairman Sean Dillon reminded all to properly post their scores.
