Rules and Regulations

Management and lifeguards control all actions around the club at all times. Managers have the right to expel members and guests from the club for failure to abide by pool rules and abusive behavior.

Membership

All members **must** show their membership card to the attendant at the entrance desk each time they enter the Club. Membership cards are not transferable, and the lending or use of cards other than your own may result in forfeiture of membership. The cost of membership cards is included in membership fees. Lost cards cost \$5.00 each to replace. Repeated replacement of pass may result in forfeiture of membership.

Children under 12 years of age MUST be accompanied by an adult (18 years or older) at all times.

Refund Policy

Membership refunds are given only **prior to Opening Day**. A processing fee of \$20.00 will be deducted from all refunds.

Refunds are not given for guest fees at any time.

Credit Cards

Visa, Master Card, American Express and Discover cards are accepted.

Guest Fees

Guest fees are \$12.00 per person everyday – children under 3 are free. After 5:00 p.m. the rates drop to \$7.00 per person – children under 3 are free. Group rates are available if set up in advance. Call for further information. Sorry, the Club does not offer rain checks or refunds in the event of inclement weather.

Members may purchase a 10 Pack of Guest passes for \$100.00 (a savings of \$20.00). Use one at a time or all at once. These passes **DO NOT** roll over from year to year.

Members are responsible for the behavior of their guests at all times and must stay with their guests on the Club premises. Guests must obey Club rules at all times. The Club is not responsible for injury of guests. Members under the age of 18 are permitted only two guests per day.

Photo Usage

Philipps Swim Club may use photos of pool and or event participants to be used on its website and social media sites. If you do not grant Philipps Swim Club permission to use your (or your child's) photo please notify a pool manger to complete an exclusion form.

General Discipline

- Abusive, vulgar, and obscene language can result in expulsion.
- Abusive use of alcohol or drugs (illegal or legal) can result in expulsion. Due to safety concerns, anyone who appears appreciably impaired may be asked by management to leave the club.
- Stealing and vandalism will result in suspension, prosecution, and/or forfeiture of membership pending property owner, management, and board action.
- Tampering of lockers will result in suspension or forfeiture of membership.

Pool Rules

- Please see signs by slides for rules for each slide.
- Dunking, harassment, and pushing people into the pool are strictly prohibited.
- Members and guests must be able to swim the width of the pool to enter the deep water. There are NO exceptions. Lifeguards maintain the right to test swimmers at any time who do not appear strong enough to swim the deep water. Flotation devices are permitted only during adult swim.
- The Diving Board is restricted for deep water swimmers only. Divers must either swim to the deep end pier, use the ladder closest to the diving board, or swim to the pool side to exit the pool. Do not swim back under the diving board to exit. Only one bounce allowed. Once one walks to the end of the board, one must jump off the board. The diving board will be closed during adult swims.
- Family appropriate swim attire must be worn at all times. This is up to manager's discretion.

Food and Drink

- Eating is allowed on the upper deck, concrete area and grassy area, but not on the pool deck.
- Drinks are allowed on the upper deck, concrete, grass, and pool deck. You must be within arm's reach of your drink by the pool side if you are drinking while in the pool.
- Glass bottles and containers of any kind are strictly prohibited from the club at all times.
- Smoking or vaping is not permitted on the pool deck, in locker rooms, or on the upper deck. There are non-smoking tables marked nearest the pool.

Brief history of Philipps

Built in 1929, at the height of the Great Depression, Philipps stands as a testimony to the indomitable American spirit, having served as a gathering place and social hub for West Side families through economic crises, wars, and a devastating fire that burned the facility to the ground in 1939. It survived closure in 2011 as a commercial enterprise when it was taken over by its members and operated as a "not-for-profit" organization maintained through volunteer labor and summer staffing.

Over the years, Philipps has hosted literally hundreds of graduation parties, birthday celebrations, family reunions, 4th of July events, midnight swims, moonlight movies, corn hole and trivia tournaments, and even a few "in pool" weddings. In addition to recreational swimming and playground facilities, Philipps also offers swim lessons for individual 3 years and up, and has a competitive swim team for kids 17 and under. By striving to maintain a peaceful and friendly oasis for community members trying to escape the hectic pressures of everyday life, Philipps lives up to its motto, "Philipps, it's not just a pool, it's a lifestyle".
