Carolyn Jefferson-Jenkins, PhD

As chair of the league's Voter Education Fund, Jefferson-Jenkins promoted democracy-building efforts in Argentina, Uruguay, Brazil, the Netherlands, Israel and a group of African countries.

She is the author of *The Road to Black Suffrage* and *One Man, One Vote: The History of the African-American Vote in the United States*. Her most recent book, *The Untold Story of Women of Color in the League of Women Voters*, was released last year in honor of the organization's centennial celebration.

Edwin C. Williams, Sr.



On April 27, 1943, Edwin Clifford Williams, Sr., a 32-year-old Black man, dared to defend his family from three white U.S. Navy sailors who were stationed in Algiers. As the Williams family walked home from Beautiful Zion Baptist Church under the Algiers viaduct at Pacific Avenue and Newton Street, Walter Curry Sherwood and two other U.S. Navy Sailors poured beer on the Williams family. Upon hearing the protestations of Mr. Williams, the sailors descended from above the viaduct with a broken beer bottle and fatally beat and stabbed Mr. Williams in front of his wife, Lillian Williams, and two youngest children. The next day, seeking justice, Mrs. Williams gave a statement to the New Orleans Branch of the N.A.A.C.P. about the fatal attack. After a hurried investigation, charges were filed only against Walter Curry Sherwood. In June of 1943, Sherwood was tried for manslaughter and acquitted after only 55 minutes of deliberation by an all-white jury. The U.S. Navy never disciplined Sherwood for killing Mr. Williams. This case was investigated in pursuit of truth and justice by the Civil Rights and Restorative Justice Project.







This exciting and informative conference will be held in Tallahassee, Florida, and promises to generate considerable intellectual dialogue and debate, as well as create opportunities to strengthen existing networks and forge new ones.

The National Civil Rights Conference will coincide with (1) the Annual Mississippi Civil Rights Memorial Service: an annual event remembering and honoring the three slain civil rights workers (James Earl Chaney, Andrew Goodman and Michael Schwerner) and other Mississippi civil rights movement participants; (2) memorial activities on the grounds of the Mt. Zion United Methodist Church; and (3) memorial activities on the grounds of the Mt. Nebo Baptist Church.

The National Civil Rights Conference is soliciting papers, panel sessions and workshops for the June conference. The conference theme is *Rise, Advocate and Educate: Protecting Our Future*. While the conference program planning committee welcomes papers, panels and artistic productions on any aspect of human and civil rights, priority will be given to submissions directly related to the conference theme.

The deadline for submission of paper, panel and artistic production proposals is April 1, 2023. Proposals should be submitted electronically and must include the title of paper or panel, author (s) name and affiliation (s), 200 to 250-word abstract of the paper or panel, and contact information. Proposals should be submitted to: kdparker@civilrightsconference.com.

Conference attendees and program participants are required to register for the conference. Registration includes admission to all sessions, and exhibit halls and daily keynotes. Service-learning training/registration (10 to 20 instructional hours or 1.0 to 2.0 CEUs) will be offered (at a small fee) to registered participants and specific audiences such as teachers, principals, and education leaders.
