VENDOR EVENT INFORMATION

IMPORTANT: Know your vendor number!

You will be given a map, street address and vendor number. You will see your vendor number on blue tape on the curb. Center your booth on the blue tape, back tent legs against the curb. You must set-up in your designated vendor spot.

After unloading, relocate your vehicle to a public parking lot or street parking. Vehicles cannot stay parked next to your booth. Exit the venue near to your booth, do not drive thru the venue.

Our Vendor Manager will visit your booth location to check you in and answer questions.

8:30am - All vendor vehicles must be cleared. For safety reasons, if your space is still vacant at 8:00am without representation, it will be forfeited. There are spectators who arrive early and the street will be filling up, so all vendor vehicles have to be cleared. No refunds for forfeited spaces.

9:00am – All booths and/or food trucks ready for the public

10:00am - Event begins with the USMC Color Guard presentation

2:45pm - Begin breaking down and packing up

IMPORTANT: There is NO early departure before 3:00pm. The street is full of pedestrians. You must wait for the Sheriff to clear and re-open the street to allow the show cars to egress.

3:00pm - Event ends, you may move your booth items to the sidewalk as you pack up.

4:00pm - Barricades are removed and streets are open to general public and traffic. All vendor booths & trailers must be off the streets or may be towed.

Additional Information:

- The City requires a 20' clearance in the center of the street at all times for emergency vehicle access
- All items are to be contained within your 10x10 space—no spreading out
- Your pop-up tent back legs must be touching the street curb
- All four corners of tent legs must be weighted down in case of sudden wind—public safety is critical
- There is no available electricity and plugging into a store's outlet or a street outlet and running an extension cord is prohibited. This firm rule will be monitored. A quiet, NON-GAS generator is OK.
- No amplified sound is allowed
- NO COOKING IS ALLOWED. All food must be prepackaged. (Exception: food trucks and those with special permission.)
- No styrofoam is allowed per City regulation. No dumping into street drains
- Trash, food debris, residue, and other waste must be removed at the conclusion of the event. If not, you will be charged a clean-up fee.

IMPORTANT: Appropriate permits and licensing is REQUIRED.

FV FOOD & DRINK VENDORS (even pre-packaged food)

In addition to a San Clemente annual or 1-day out-of-town business license, vendors selling food or drinks (even pre-packaged food) must obtain a permit from the OC Health Department.

You must supply one of these two types of OC Health permits:


TFF Permit required for food booths, also known as Temporary Food Facilities (TFF). When no cooking or food prep is taking place. This is the only type of food booth permitted.

OR

MFF Permit required for carts and trucks, also referred to as Mobil Food Facilities (MFF). This is when food prep is taking place, only food trucks would be in this category.
