SR 732/Jensen Beach Causeway Mobility Improvements Project

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-person Construction Open House regarding upcoming improvements to SR 732/Jensen Beach Causeway in Jensen Beach. Please see below for detailed meeting information.

Construction Cost: \$3 million

Construction Start: September 2023

Estimated Completion: Summer 2024

PROJECT IMPROVEMENTS

- Milling and resurfacing the existing roadway
- Replacing damaged sidewalk
- Upgrading pedestrian curb ramps to meet Americans with Disabilities Act (ADA) standards
- Upgrading signing and pavement markings to provide buffered bicycle lanes
- Replacing existing bridge lighting, pendant lights and decorative pier lights

TRAFFIC IMPACTS

- Lane closures on SR 732/Jensen Beach Causeway are permitted nightly, Sunday through Thursday from 10:00 p.m. to 6:00 a.m.
- Lighting work performed within the causeway park is permitted nightly Sunday through Thursday from 10:00 p.m. to 6:00 a.m. Two parking spaces on either side of the pier may be utilized for the work zone.
- During Phase 1 of construction, the regulatory speed limit within the work zone will be 35 miles per hour. Work zone speed for all remaining phases will be 40 miles per hour.
- Sidewalk and curb ramp construction at NE Breakwater Drive, NE Moon River Circle, Fairwinds condo entrance, and NE Jensen Beach Circle will be staggered to ensure accessibility to and from residential areas. Pedestrian access will be maintained at all times.
- One direction of sidewalk will remain open at all times.
- Business and residential access will be maintained at all times.
