

**CERTIFICATE OF VOTE TO OPT-OUT AND FOREGO RETROFITTING
FAIRWINDS COVE CONDOMINIUM ASSOCIATION OF HUTCHINSON ISLAND, INC.
WITH A FIRE SPRINKLER SYSTEM**

WHEREAS, FAIRWINDS COVE CONDOMINIUM ASSOCIATION OF HUTCHINSON ISLAND, INC. (hereinafter Association) is a Florida not-for-profit corporation which operates and maintains FAIRWINDS COVE OF HUTCHINSON ISLAND, A CONDOMINIUM (the Condominium) according to the Declaration of Condominium thereof as recorded in Official Records Book Public Records of Martin County, Florida

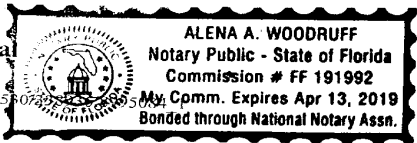
