By Signing Below I/We accept the following **Payment Policies**:

- La Escuelita LLC enrolls students on a monthly basis. Hence, your student is registered for La Escuelita's calendar month to month. The renewal of their assistance at La Escuelita LLC is done automatically- unless you inform us a month before.
- Your student may join our class at any time during the month. Our program is designed to work with your student at their own level at any point when they start. We will pro-rate the first month depending on the number of classes the student takes.
- At the time of registration, a \$100 Non-refundable registration fee is collected.
- Please note that tuition prices and fees are subject to change. For the most up-to-date information, kindly contact the director.
- At La Escuelita, we request that monthly tuition payments be submitted during the registration process and no later than one week prior to the start of each month (within the last 7 days of each month). Timely payments ensure your student's enrollment in their regular class every week throughout the corresponding month.
- \*\*\*\$20.00 late fee applicable for tuition received late NO EXCEPTIONS
- If you or your student, for any reason, need to terminate or reschedule future classes we require one month's written notification. This can be via text, email, or letter. In the event that we have not received written notice at least one month in advance, we retain the right to invoice tuition for the entire month.
- \*\*\*\$20.00 rescheduling fee applicable for changes made without one month notice NO EXCEPTIONS
- We offer a 10% student discount for siblings who attend class twice a week (totaling a minimum of 4 classes a week). If the students reduce their classes to once a week (thus, two classes in total), we reserve the right to withdraw the 10% discount from your total monthly bill.

By Signing Below, I/We accept the following Attendance Policies:

• If your student misses a class, we do offer make-up classes. However, your tuition must be current and you must inform us no later than 9:00 AM of the class day, and for



Saturday students, you need to inform us no later than Friday, 5:00PM. Make-up classes only extend to <u>ONE class per billing month</u>. Make-up classes are <u>not</u> guaranteed. Additionally, if a make-up class is missed, we cannot reschedule it- therefore, the class will be lost (even if it was paid in full).


- If you would like to schedule a make-up class for your student, you must call, text, or email us in advance to help us maintain proper student/teacher ratios in our classes.
- La Escuelita LLC will make every effort to accommodate your make-up needs; however, we do not provide refunds for missed classes NO EXCEPTIONS.
- In the event that your student is absent for the first two classes of the month and payment has not been received, your registration will be forfeited. To re-register, it will be necessary to submit the registration fee once more.

By Signing Below, I/We accept the following 'Pick-Up' Policies:

- Only parents, legal guardians, and people authorized in writing by the parent with physical custody may pick up a student from student care.
- To ensure your student's safety, please notify La Escuelita LLC, in writing, that someone other than you will pick up your student. We will ask the individual to present La Escuelita LLC with proper identification.
- If you, or whoever is picking up your student, is aware that they are going to be late, they should call La Escuelita LLC to advise staff of this and of their plan to pick up their student. Due to the operational and staffing costs incurred when a parent/guardian is late, a late fee will be charged.

#### • When the parent/guardian is late:

- 1. We will contact the parent/guardian at the numbers on the student 's file card
- 2. If contact with parent/guardian is not established, we will call the emergency contact(s) on the student's file card and make arrangements for the student to be picked up.
- 3. In the event that you and the emergency contact(s) are not available and it is 30 minutes past established pick-up time; we will contact the appropriate Children's Aid Society and follow their instructions.
- 4. If the parent/guardian is repetitively late, we reserve the right to terminate our aforementioned school contract and will not issue a refund if classes are canceled due to late pick ups.
- The late fee schedule is as follows:
  - The **first** time a late pick-up occurs, a \$5 fee will incur for every 10 minutes past the pick-up time.
  - The **second** time a late pick-up occurs, a \$10 fee will incur for every 10 minutes past the pick-up time.






• If late six times in any four-week period the parent/guardian and student will face explusion from La Escuelita LLC.

## By Signing Below, I/We accept the following **Bully Prevention Policies:**

- La Escuelita LLC believes all students have a right to a safe and healthy school environment. We have an obligation to promote mutual respect, tolerance, and acceptance.
- La Escuelita LLC will not tolerate behavior that infringes on the safety of any student. A student shall not intimidate, harass, or bully another student through words or actions. Such behavior includes: direct physical contact, such as hitting or shoving; verbal assaults, such as teasing or name-calling; and social isolation or manipulation.
- La Escuelita LLC expects students and/or staff to immediately report incidents of bullying to the teacher or Director. Staff who witness such acts take immediate steps to intervene when safe to do so. Each complaint of bullying should be promptly investigated. This policy applies to students on school grounds, while traveling to and from school or a school-sponsored activity whether in or around the classroom setting.
- Each school will adopt a Student Code of Conduct to be followed by every student while at La Escuelita LLC, or when traveling to and from school or a school-sponsored activity, whether in or around the classroom setting.
- The Student Code of Conduct includes, but is not limited to:
  - Any student who engages in bullying may be subject to disciplinary action up to and including expulsion from La Escuelita LLC.
  - Students are expected to immediately report incidents of bullying to the teacher or Director.
  - Students can rely on staff to promptly investigate each complaint of bullying in a thorough and confidential manner.
  - If the complainant student or the parent of the student feels that appropriate resolution of the investigation or complaint has not been reached, the student or the parent of the student should contact the Director.


By Signing Below I/We:


I further understand and agree that this release, discharge, waiver, and assumption of risk is to be binding on my and my student's heirs, executors, administrators, and assigns.


### **Regarding Coronavirus (COVID-19):**

During this pandemic we are all trying to remain educated to make sure we are taking the right precautions.
