URGENT CALL FOR INVESTIGATION INTO GUARDIAN AD LITEM *BRIAN BARON IN ORANGE COUNTY, CALIFORNIA

We, the undersigned, are collectively **demanding** an immediate investigation into **Brian Baron**, the Guardian ad Litem (GAL) in Orange County Family Court. While we may not have all directly interacted with **Brian Baron**, **we have been affected by the same issues and misconduct** that have led us to request this investigation.

We represent a **group of concerned families and individuals** who have faced similar challenges in their family court cases. We are speaking out because we believe that **his actions**, and the actions of others like him, have **compromised the integrity of family court decisions**, resulting in **unjust outcomes** for **minors** and **families**.

The issues we have encountered include, but are not limited to:

- **Tampering with family cases**, causing significant harm to minors and families.
- **Over-billing for services**, placing financial strain on families in crisis. Slapp Motions & Vexatious Litigations to Retaliate and Silence families who stand up against him.
- **Failure to interview petitioners**, and **failure to review critical case evidence**, leading to biased and unjust decisions.
- **Protecting accused parties** without due diligence or accountability, leading to wrongful outcomes.
- **Improper influence** over family court rulings, with a disregard for professional responsibilities and ethical conduct.

Additionally, we are deeply concerned about the **personal relationships** that have allegedly interfered with **Brian Baron's** professional conduct. His ex-husband and current live-in partner, **Wesley Wuchner**, along with his assistant **Rebecca Galvan**, both of whom have allegedly acted without proper authorization (**not** attorneys or appointees of the court), have been involved in inappropriate actions, including:

- **Wesley Wuchner** allegedly interviewing petitioners and asking to view minors over the internet instead of conducting formal interviews.
- **Brian Baron** allegedly attempting to force entry into a family's home, where he reportedly banged on the door to gain access, causing distress to the family.
- **Rebecca Galvan** and **Wesley Wuchner** allegedly collecting second-hand information from minors and others involved in the case, which was then passed to **Brian Baron** and used to draft biased reports that resulted in the wrongful removal of minors from their advocates.

Moreover, **children have been placed in the homes of accused parties** without proper investigations or consideration of the children's safety and well-being. This has

led to **devastating consequences** for families across Orange County and California, as these improper placements have resulted in harm to children who were not properly safeguarded. These actions are a **violation of legal codes** that are designed to protect the **best interests of minors**.

We are also concerned about the **obstruction of justice** caused by **moot motions for contempt** and the **removal of Brian Baron** in cases that have already been closed. This creates a **loophole** that prevents **proper accountability** for **Brian Baron**, leaving families without the opportunity for justice, even after serious allegations and improper conduct.

We, as a collective group of concerned individuals and families, demand that the **Grand Jury** investigate **Brian Baron**, his actions, and the potential harm he has caused. The **families of Orange County** and California deserve **transparency, justice, and accountability** for these abuses.

We ask that the **Grand Jury** take immediate action to ensure the **integrity of the family court system** and the **protection of minors**. The time for accountability is now.

WHAT ACTION SHOULD THE GRAND JURY TAKE?

We, the undersigned, respectfully request that the **Grand Jury** take immediate action regarding the serious allegations against **Brian Baron**, Guardian ad Litem in Orange County Family Court. We urge the Grand Jury to:

1. **Launch a Thorough Investigation:** Investigate Brian Baron's conduct as Guardian ad Litem, focusing on potential misconduct, tampering, overbilling, and unethical practices that may have harmed minors and families.
2. **Review All Relevant Cases:** Examine cases where Brian Baron was involved, particularly instances of bias, failure to review critical evidence, and improper influence on rulings. This includes his interactions with Wesley Wuchner and Rebecca Galvan, who were allegedly involved in unauthorized interviews and tampering.

3. **Investigate Financial and Ethical Violations:** Investigate allegations of over-billing and improper financial practices, along with potential conflicts of interest arising from **Brian Baron's** personal relationships with **Wesley Wuchner**.
4. **Ensure Proper Child Placement:** Investigate cases where children were placed in the homes of accused parties without proper investigation or safeguards, resulting in harm to minors.
5. **Recommend Accountability:** Based on the findings, recommend the removal of Brian Baron as Guardian ad Litem and implement measures to restore accountability, including possible legal or financial penalties.
6. **Strengthen Oversight:** Advocate for stronger oversight in the Family Court system to prevent future abuses of power, ensuring transparency and the protection of minors.
7. **Commitment of Perjury:** Brian Baron has committed perjury in court multiple times by falsely stating that he met with minors, only to later admit that his ex-husband, Wesley Wuchner, and his assistant, Rebecca Galvan, were the ones actually conducting the interviews with the minors. This misrepresentation undermines the integrity of the court process.
8. **Avoiding Motion for Contempt and Removal:** Brian Baron has avoided motions for contempt by failing to meet with petitioners and review critical case evidence, as required by court orders. Instead, he delegated these responsibilities to individuals who are neither attorneys nor authorized to perform these tasks, despite explicit instructions in a minute order by the judge.
9. **Fraudulent Conversion of Public Assistance Funds:** Brian Baron has allegedly forced families currently on public assistance to pay his legal fees, threatening retaliation in court by recommending the removal of children from these families if they fail to comply. He is illegally converting public assistance funds into his legal fees, which is both fraudulent and unethical.

The **Grand Jury** must act swiftly to investigate these allegations, protect vulnerable families, and restore integrity to the family court system.
