Privacy Policy

This Privacy Policy ("Policy") applies to eschomeservices.com, and ESC Home-Services Inc ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include eschomeservices.com. The Company's website is a cleaning service site. By using the Company website, you consent to the data practices described in this statement.

California Consumer Privacy Act and California Privacy Rights Act

Collection of your Personal Information
