5. Facilities. Event Organizer offers facilities for the Workshop's perusal:

- i. Projector
- ii. Space that has tables and chairs for the amount of participants

The usage of these facilities will need to be reserved with the Event Organizer.

6. Warranties. Queens Academy warrants that its Facilitator's has sufficient knowledge, skills, and experience for speaking and sharing her knowledge to the audience in the event.

Queens Academy agrees that during the term of this Agreement,

The Event Organizer agrees not to alter any of the instructions or guidelines provided for by Queens Academy to the Event Organizer without prior consent to Queens Academy made in writing and signed by the parties hereto.

7. Non-Exclusivity. Event Organizer does not hold exclusive engagement with Queens Academy. Queens Academy may choose to engage with any other business activities that are not directly in competition with the Event Organizer that may lead to failure in rendering the agreement herein.

8. Period. This Agreement is effective only for the engagement as indicated in the Event Details and shall terminate upon completion of the fulfillment of the obligation of the Parties hereto.

9. Cancellation. Should either Party wish to cancel the engagement or any part of this Agreement, the Party must notify the other for the cancellation by 48 hours.

In the event that the Event Organizer fails to give prior notice to Queens Academy that leads to any expense, the Speaker shall shoulder the expenses of the Speaker thereof.

This Agreement shall terminate in case of a breach, force majeure, or in any case the Speaker shall be unable to render her obligation, or the filing of any petition by or against the Event Organizer under Federal or State bankruptcy or insolvency laws.

10. Intellectual Property. All proprietary information shared by the Speaker shall be her own intellectual property and shall remain her own unless otherwise the Parties hereto agree that such intellectual property shall transfer to the Event Organizer.

11. Indemnification. The Parties hereto shall defend, indemnify, and hold harmless each other from and against damages, liabilities, losses, actions, or expenses arising from injury, death, from the other's acts or omissions, representation, or obligation under this Agreement.

12. Survival. Each Party's obligations arising from this Agreement shall survive the termination as to the terms and conditions by which it imposes continuing obligations.

13. Dispute Resolution. In case of a dispute arising from this Agreement between the Parties, the dispute shall primarily be resolved by arbitration. The arbitrator shall be elected by both Parties. Legal fees shall be shared by and between the Parties hereto other than the attorney's fees which will be paid solely by the each Party on their own.
