Health Guarantee

We advise that the puppy stay clear of public areas until all vaccinations are completed to help ensure immunity against diseases.

1. Health Guarantee

Yorkies of South Georgia guarantees your puppy against life-threatening congenital or hereditary defects for a period of **one (1) year** from the date of birth. Life-threatening is defined as a congenital or hereditary defect that will prevent the puppy from living a normal life expectancy. Issues excluded from this definition include, but are not limited to, bone/joint conditions, blindness, deafness, hernias, or changes in coat color or ear carriage.

If a covered condition arises, Yorkies of South Georgia agrees, at its sole election, to either:

- Provide a replacement puppy of equal value (subject to availability) **OR**
- Refund the original purchase price.

This remedy is the sole and exclusive remedy available to the purchaser.

2. Conditions of Guarantee

- The purchaser must notify the breeder in writing/text within **five (5) business days** of diagnosis.
- The purchaser must submit a **complete veterinary report**, and if applicable, a **full necropsy report** from a licensed veterinarian, documenting the life-threatening congenital defect.
- All veterinary expenses, diagnostic tests, and necropsy costs are the sole responsibility of the purchaser.
- Failure to provide the required documentation within **ten (10) business days** voids this guarantee.

3. Exclusions

This guarantee does NOT cover:

- Death or illness resulting from hypoglycemia, which is a preventable condition related to nutrition, handling, or stress.
- Conditions curable by medication or surgery.
- Adverse reactions to foods, vaccinations, or medications.
- Parvovirus infection.
- Parasites, ear mites, fleas, ticks, worms, giardia, and coccidia.

4. Purchaser Responsibilities

- The purchaser must have the puppy examined by a licensed veterinarian within **7 days** of receiving the puppy.
- Proof of vaccinations and ongoing veterinary care must be maintained and provided upon request.
- Failure to provide routine veterinary care voids this guarantee.

5. Surrender and Rehoming

If the purchaser is unable to retain ownership of the puppy for reasons not covered under this guarantee, the puppy **must be returned** to Yorkies of South Georgia. Refunds in such cases are **not guaranteed** and are at the breeder's sole discretion.

6. Limitation of Liability

Yorkies of South Georgia is not liable for any incidental, consequential, or emotional damages resulting from the puppy. The maximum liability under this agreement shall never exceed the original purchase price of the puppy.

7. Governing Law and Venue

Any disputes arising under this agreement shall be governed by the laws of the State of Georgia. Venue for any legal action shall be exclusively in **Tift County, Georgia**.
