

TERMS AND CONDITIONS

Last Updated: March 2026

These Terms and Conditions (“**Terms**”) govern your access to and use of the website located at <https://visonixstudios.com> (the “**Site**”), which is operated by Visonix, LLC, a Texas limited liability company (“**Visonix**,” “**we**,” “**us**,” or “**our**”).

By accessing or using the Site, you agree to be bound by these Terms. If you do not agree, you may not access or use the Site.

- 1. Eligibility.** The Site is intended for users who are at least thirteen years of age. Visonix does not knowingly permit access to or use of the Site by children under the age of thirteen. By using the Site, you represent and warrant that you meet this eligibility requirement.
- 2. Purpose of the Site.** The Site is provided for informational and promotional purposes only. The Site may include, without limitation:
 - Descriptions of games created or published by Visonix
 - Developer updates and upcoming game changes

Any dispute arising under or relating to these Terms is to be brought or commenced in federal or state court having jurisdiction in Rockwall County, Texas.
