**Delhi: Speeding car falls off Vikaspuri flyover, 2 injured**

New Delhi At least two persons were injured late Thursday night when their car fell off a flyover in West Delhi's Vikaspuri area. The Delhi Police said the accident took place around 11 pm on Thursday. "One of the injured was shifted to DDU hospital while the another was rushed to a private hospital," Deputy Commissioner of Police (West) Deepak Purohit said. The accident took place after driver of the car lost control of the vehicle and hit another car after it fell off the flyover, news agency ANI reported. Police added that a case under sections 279 (rash driving or riding on a public way) and 337 (causing hurt by act endangering life or personal safety of others) of the Indian Penal Code (IPC) has been registered at Vikaspuri police station and investigation is in progress.

**Drugs worth over Rs 5 crore seized in Assam's Karbi Anglong, 1 arrested**

Guwahati Police seized contraband drugs worth over Rs 5 crore and arrested a person in Assam's Karbi Anglong district on Thursday. According to reports, Karbi Anglong district police recovered the drugs from a truck during regular checking in Manja area in the hill district on Thursday evening. The truck bearing registration number NL-07A-8201 was coming from Dimapur in Nagaland to Guwahati. Police stopped the vehicle at Manja police checkpoint.

During checking, police recovered a huge quantity of WY tablets which were concealed in different packets. A police official of Karbi Anglong district said that police arrested the driver of the truck, identified as Imran Khan. He said that the contraband drugs were kept hidden at the back of the driver seat.

**BJP hits out at AIMIM MP for 'ultimatum' to Maharashtra govt to reopen religious places**

\*BJP's NV Subhash said demanded police to book AIMIM MP Imtiyaz Jaleel for instigating people on religious lines. The AIMIM MP had earlier given an ultimatum to the Maharashtra govt to reopen temples and mosques.

Hyderabad The Bharatiya Janata Party (BJP) has hit out at AIMIM MP Imtiyaz Jaleel after he said he will offer namaz on roads if mosques are not reopened. Reacting to All India Majlis-e-Itehad-ul Muslimeen (AIMIM) MP's tweet where he questioned the Maharashtra government over its decision not to reopen places of worship, BJP leader NV Subhash said the "ultimatum" given by AIMIM was "ridiculous" at a time when the country is still fighting coronavirus. BJP leader NV Subhash is the grandson of former Prime Minister PV Narsimha Rao. Being a Parliamentarian, the AIMIM leader should not provoke Muslims on religious lines when the nation is yet to reach



normalcy," said Subhash, and asked, "How can he give warning to the state that he will fill the streets with Muslims for namaz demanding the opening of mosques." BJP leader pointed out that Maharashtra has the highest number of coronavirus cases in the country. He also demanded a case against the MP for instigating people on religious matters during the pandemic. Rejecting the MP's comparison of opening of mosques with Ganesh Visarjan, the BJP leader said it was not fair as immersion of Ganesh idols was an event which would be completed in one or two days and which will follow lockdown precautions. The BJP leader's

comments came days after the AIMIM MP took to Twitter and demanded reopening of mosques. "When businesses, factories, markets have opened up even buses, trains & flights are operating who told govt Corona will spread only from religious places! Govt's revenue-earning liquor shops are also open & even limited people can gather for marriages so why shut only religious places!" Imtiyaz Jaleel wrote. "We all waited and cooperated with the govt for six months to improve our medical infrastructure now that everything is open why keep shut only religious places! Illogical. My ultimatum to Maharashtra govt to open all Mandirs from sept 1 and we will open all masjids from sept 2!" the AIMIM MP said. He said if his demands are not met, he would offer namaz on the roads itself. The AIMIM MP also tweeted on NEET controversy and said, "Are exams more important than life! Obviously the government doesn't care much for students life. Else why would they conduct exams when the pandemic is still on. And if the Corona fear is gone then first call Parliament session and test how many of your BJP MPs attend!"

**Rajnath Singh to formally induct Rafale on September 10 at Ambala, French Defence Minister invited for event**

New Delhi In a major boost to the Indian Air Force (IAF), Defence Minister Rajnath Singh will officially induct the first five Rafale fighter aircraft into service at the Ambala air base on September 10.

India has also invited French Defence Minister for the event in Ambala, officials said. "The first five Rafales are going to be inducted into the Indian Air Force on September 10 by Defence Minister Rajnath Singh. India is also inviting the French Defence Minister Florence Parly for the event," top government sources told India Today on Friday.

The first five aircraft had arrived from France in India on July 29. The Indian Air Force had then stated that the planes will be inducted into the IAF after a formal ceremony. In the first tranche, India got five fighters from France including three single-seated and two twin-seated trainer aircraft.

The Air Force has been training on the planes soon after they arrived from France and have flown extensively over the Ladakh region where India is locked in a conflict with China on the border.

The fighters have been armed with deadly Meteor, MICA, SCALP and Hammer Missiles to take out its targets in both air and on ground. The plane will be inducted with the rest of the Indian Air Force fighter aircraft fleet, including Sukhoi and MiG-29s, which are going to be the mainstay of the force in the coming years along with French aircraft in the main lead. The first Rafale jet was handed over to the IAF in October last year during Rajnath Singh's visit to France. While the first squadron of the Rafale jets will be stationed at Ambala air base, the second one will be based at Hasimara air base in West Bengal.

The IAF has reportedly spent around Rs 400 crore to develop required infrastructure such as shelters, hangars and maintenance facilities at the two bases.

**Covid-19: What you need to know today**

According to research by Akiko Iwasaki and others at the Yale School of Medicine, the male immune response is largely built around cytokines and chemokines, both signalling proteins that are part of the body's immune response. The female response, the research, published in Nature says, is driven by T-cells, a major (and stronger) component of the immune system. The research offers the first plausible answer on why the mortality rate among infected men, especially those over the age of 60, is higher than that among infected women. As an aside, those interested in the more scientific aspects of Covid-19 would do well to follow Iwasaki's work — she is among the clearest thinkers on many aspects of the disease.

**2-storey shopping complex collapses in Ahmedabad; 1 dead, 2 rescued**

New Delhi At least one person died when a two-storey shopping complex building collapsed in Kubernagar area of Ahmedabad on Friday.

Two persons have been rescued so far, officials said. This comes a day after two minor sisters died when a wall of their house suddenly collapsed at a village in Gujarat's Bharuch district.

The collapse was triggered by a wall from an adjoining house crashing on a portion of their residential structure, a police official said on Thursday. The incident took place at Nondhni village under Jambusar taluka when the three sisters were sleeping in their room, said police sub-inspector VR Prajapati. While 12-year-old Virali Parmar and Heena Parmar (13) were buried alive under the debris, their third sister Bhumika has been hospitalised with injuries. "When they were asleep in their semi-pucca house early today morning, a wall of adjoining house fell on their house, which triggered the collapse of wall and some portion of the roof, killing two sisters on the spot," said police. The third sister survived but received injuries on her leg, he said.
