### 1. ASSUMPTION OF RISK

I am voluntarily choosing to participate with full understanding and acceptance of all risks involved.

### 2. RELEASE AND WAIVER OF LIABILITY

In consideration of being permitted to participate in the Burnout Competition at Pro Street Mayhem, I, on behalf of myself, my heirs, personal representatives, successors, and assigns, do hereby release, waive, discharge, and covenant not to sue:

- Pro Street Mayhem organizers and staff
- Teddy Morse's Destination Daytona and its owners, management, and employees
- Event sponsors, volunteers, vendors, and affiliates
- Any and all other individuals or organizations involved in the planning, operation, or hosting of the event

from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury (including death), or property damage that may occur while participating in or observing the Burnout Competition.

### **3. INDEMNIFICATION**

I agree to indemnify, defend, and hold harmless all Releasees from any loss, liability, damage, or costs, including attorneys' fees, they may incur due to my participation in the event, whether caused by negligence or otherwise.

### **4. VEHICLE SAFETY & OPERATION**

I certify that the vehicle I am using in the competition is safe, mechanically sound, and suitable for burnout performance. I agree to comply with all safety instructions and inspections required by event staff. I will not operate the vehicle under the influence of drugs or alcohol. Failure to follow rules may result in disqualification and removal from the event.

### **5. MEDICAL AUTHORIZATION**

In the event of an injury or medical emergency, I authorize the event staff or emergency personnel to secure medical treatment on my behalf. I agree to be responsible for all costs associated with such treatment.

### **6. MEDIA RELEASE**

I consent to the use of my name, voice, image, vehicle, and/or likeness in photographs, videos, and promotional materials taken at or during the event, without compensation or approval rights.

### **7. GOVERNING LAW AND JURISDICTION**

This agreement shall be governed by and construed in accordance with the laws of the State of Florida. Any legal action arising out of this waiver shall be brought in a court of competent jurisdiction in Volusia County, Florida.
